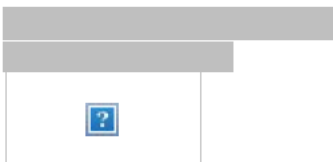
On behalf of Mr Sadauskas I would like to thank you for your message and the request to meet and discuss European Commission's work on PFAS.
