Points to emphasize in notes:

- From Henry-- it would be helpful for Alex/Todd/Martha to say that this work has already begun-- we are not waiting for the future of cooperative federalism, this relationship has already started
- Both groups are embracing the process
- It is about improving processes-- it is not a wish list but how we work better together

- Strong EPA & Strong States
- Cyclic, opportunity to modernize/streamline
- Positive State-EPA tone throughout presentation
