
This letter is regarding the Ann Arbor Area Transportation Authority's (AAATA's) grant applications for \$7,220,095 in federal funding for the Ypsilanti Transit Center (YTC) and for \$5,282,807 in federal funding for Bus Replacement through the Grants for Buses and Bus Facilities Program.
