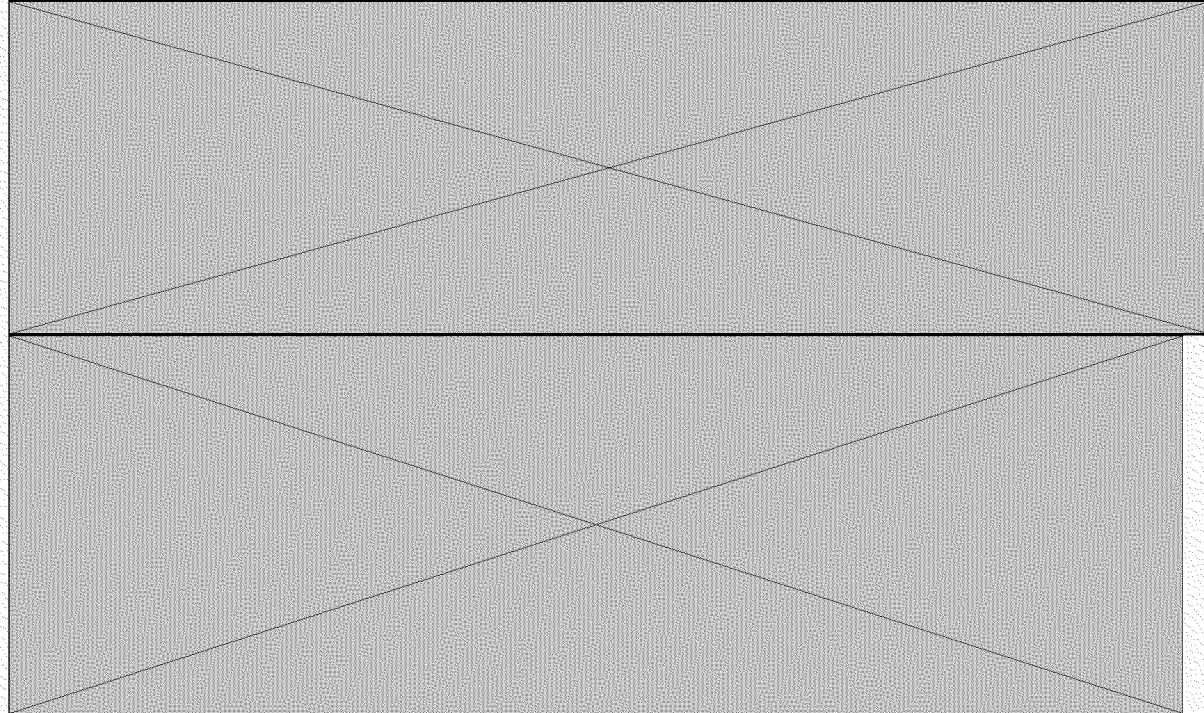

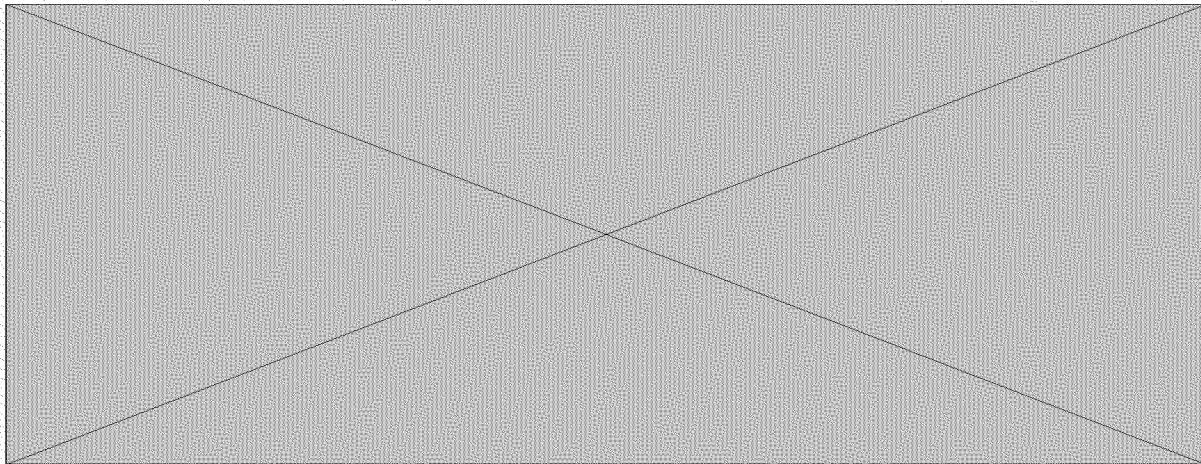

Update on 2017 SMCI Ramsay Awards Process

In April, the Solve ME/CFS Initiative announced our request for proposals for the 2017 Ramsay Award Program. We received applications from 6 different countries. This investment in seed grants through an open competition, reflects our commitment to participatory research and inclusivity to advance the field of chronic fatigue syndrome research and amplify the work of our grantee researchers. Currently, the 2017 applications are being peer reviewed and we anticipate the final announcements of the 2017 Ramsay Award projects and partners in October.

Partnering with Llewellyn King of the Youtube program “ME/CFS Alert”



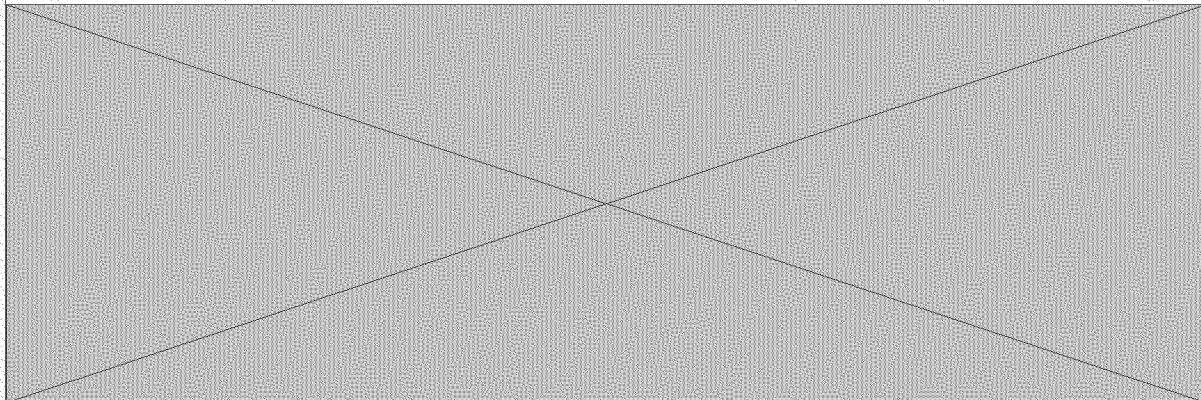

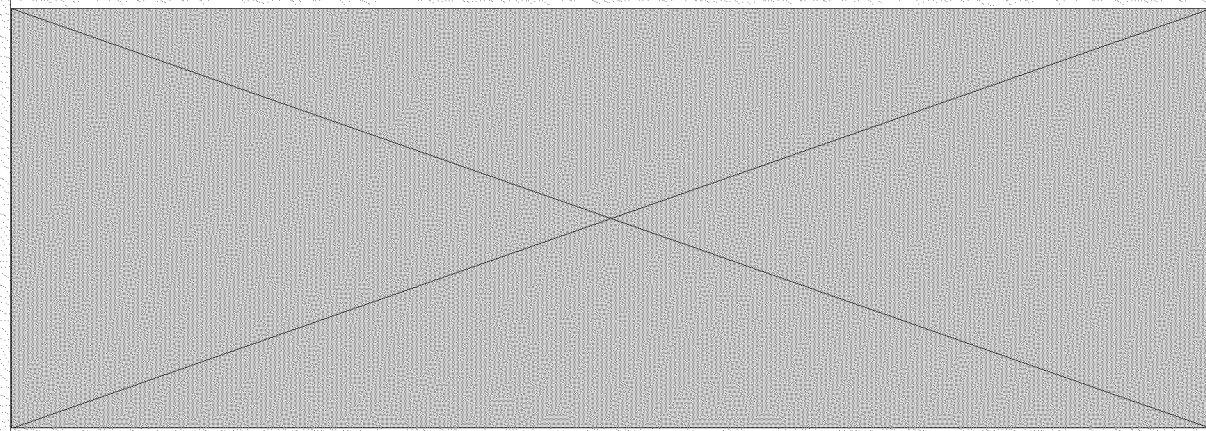
