You'll remember that you signed your nominee financial disclosure report back in June, so now I am asking you to update your information to reflect income or honoraria received since then. Here's the introductory text of the letter:

Dear Mr. Chairman:

The Ethics in Government Act of 1978, as amended, provides that Presidential nominees for a position requiring the advice and consent of the Senate shall update their public financial disclosure report with respect to any outside earned income and honoraria received through the period ending no more than five days prior to the commencement of the Senate hearing of their nomination. 5 U.S.C. app § 101(b)(1) and 5 C.F.R. § 2634.606(a).

The information on my public financial disclosure report was current as of June 2, 2017. In the intervening period, through September 15, 2017, I have ...
