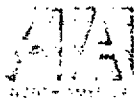

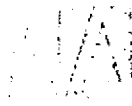

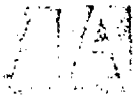

Dear Mr. Shoemaker:

In accordance with our phone conversation last week, I am forwarding herewith the information we discussed that, hopefully, will assist you in preparing for your participation in the AIA dust control panel next month. Included are copies of the two papers from which Messrs. Goldfield and Trosper are expected to extract the predominant part of their presentations. Also included is a copy of the Curtis/Bierbaum report for NIOSH on technological feasibility of achieving the OSHA 2 fiber standard in asbestos textile operations. From my file I have supplied some information on dust suppression liquids, use of foam and water sprays, water jet and laser machining, and some recent developments in brake service dust control equipment.

I have been in contact with Mr. James Gideon at the NIOSH Division of Physical Sciences and Engineering at the Taft Laboratories in Cincinnati regarding investigation of equipment and methods for improving asbestos dust control, particularly for brake service operations. I believe he or his associates can fill you in on the work they are doing and the plans they have for evaluating vacuum cleaners and other equipment for minimizing worker exposure to asbestos and other toxic materials.

For our dust control panel program, I suggest you be prepared to talk for 10 to 15 minutes on the following:

~~NIOSH Recommended Industrial Ventilation Guidelines~~
~~NIOSH Brake Service Recommendations~~
~~NIOSH investigations of Dust Control Equipment and Methods~~
Any further comments you may have regarding methods, examples, or recommendations on dust control by any means.

I expect the panel program to be arranged roughly as follows:

Introductions -- 5 minutes
Goldfield -- 15 minutes
Trosper -- 15 minutes
Shoemaker -- 15 minutes

Mr. Thurber: All of us here are intimately concerned with the
work of the Occupational Safety and Health Administration.

Without giving exaggerated attention to our problems I think

it can be said that asbestos has been a leading standards issue

in OSHA. An emergency temporary standard for exposure to as-

bestos dust was one of the first formal regulatory actions

by ~~OSHA~~ ^{OSHA} Administration following its founding in 1971. In June of 1972,

OSHA promulgated ~~a~~ ^{the permanent} regular standard for asbestos, culminating

nine months of activity and controversy. The standard was challenged

in the courts. In October of this past year, OSHA published

a) it relates to the manufacturing industry
 a proposed revision to the standard^{calling for drastic}
 lowering of the ^{allowable dust levels} standard. The Association, along with a number
 of individual member companies, has protested^{against many aspects of} the proposed new
 standard in comments submitted in April of this year in accordance
 with the rulemaking process. A date for public hearing on the
 proposed revision to the standard ^{is} yet to be announced. *but we hope*
that this morning's statement may have some impact to say on that
 Meanwhile a standard for exposure to asbestos in the construction *5-6-74*
 industry is in the developmental process. The Association has
strongly urged OSHA to defer action on the proposed revision to the
 general or manufacturing standard until after a proposed con-
 struction regulation has been published and its potential impact
on the asbestos standard is
 measured.

This morning we are privileged to have with us two
 special representatives from Dr. Morton Corn's office to discuss

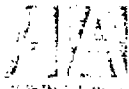
