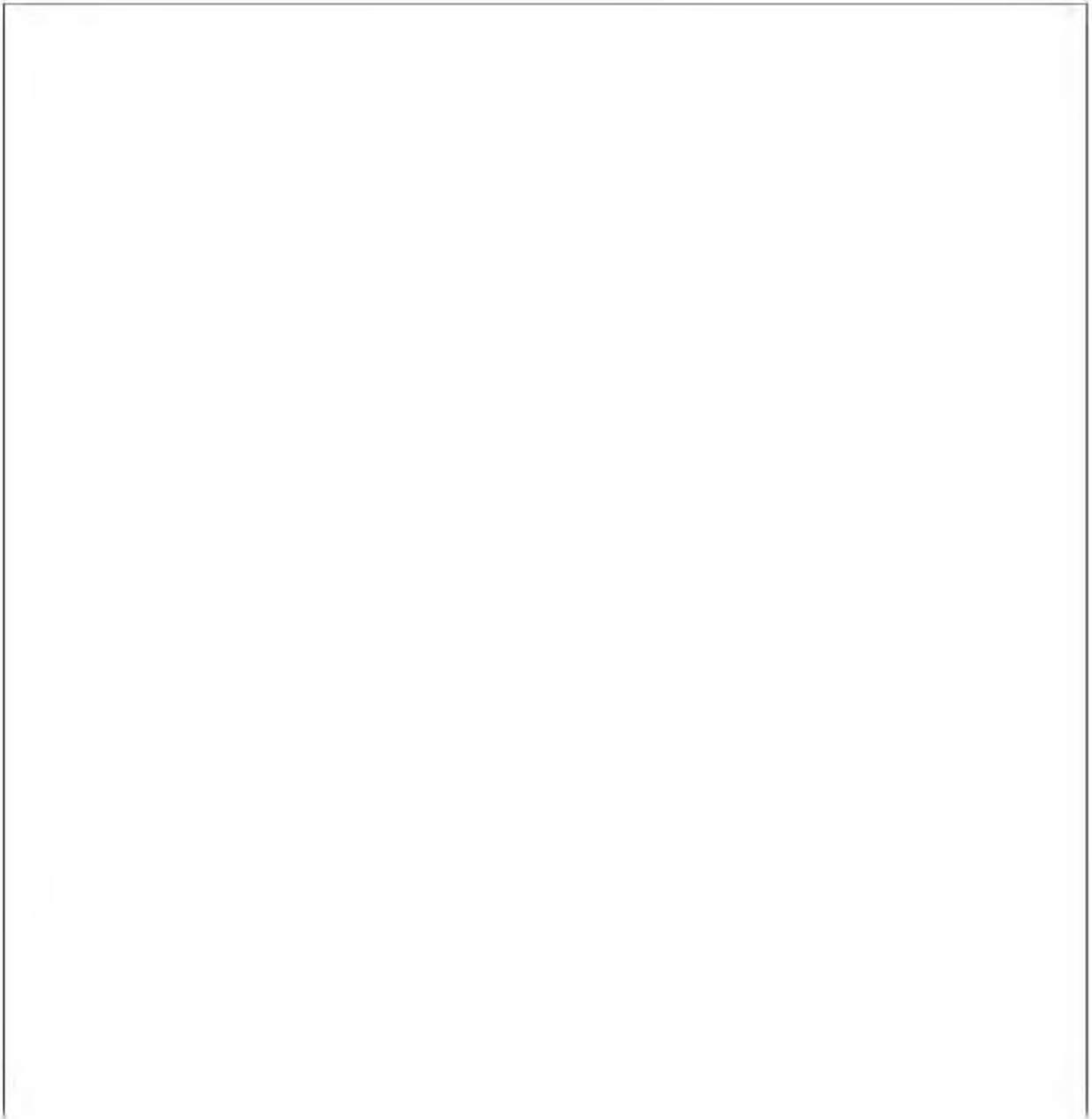

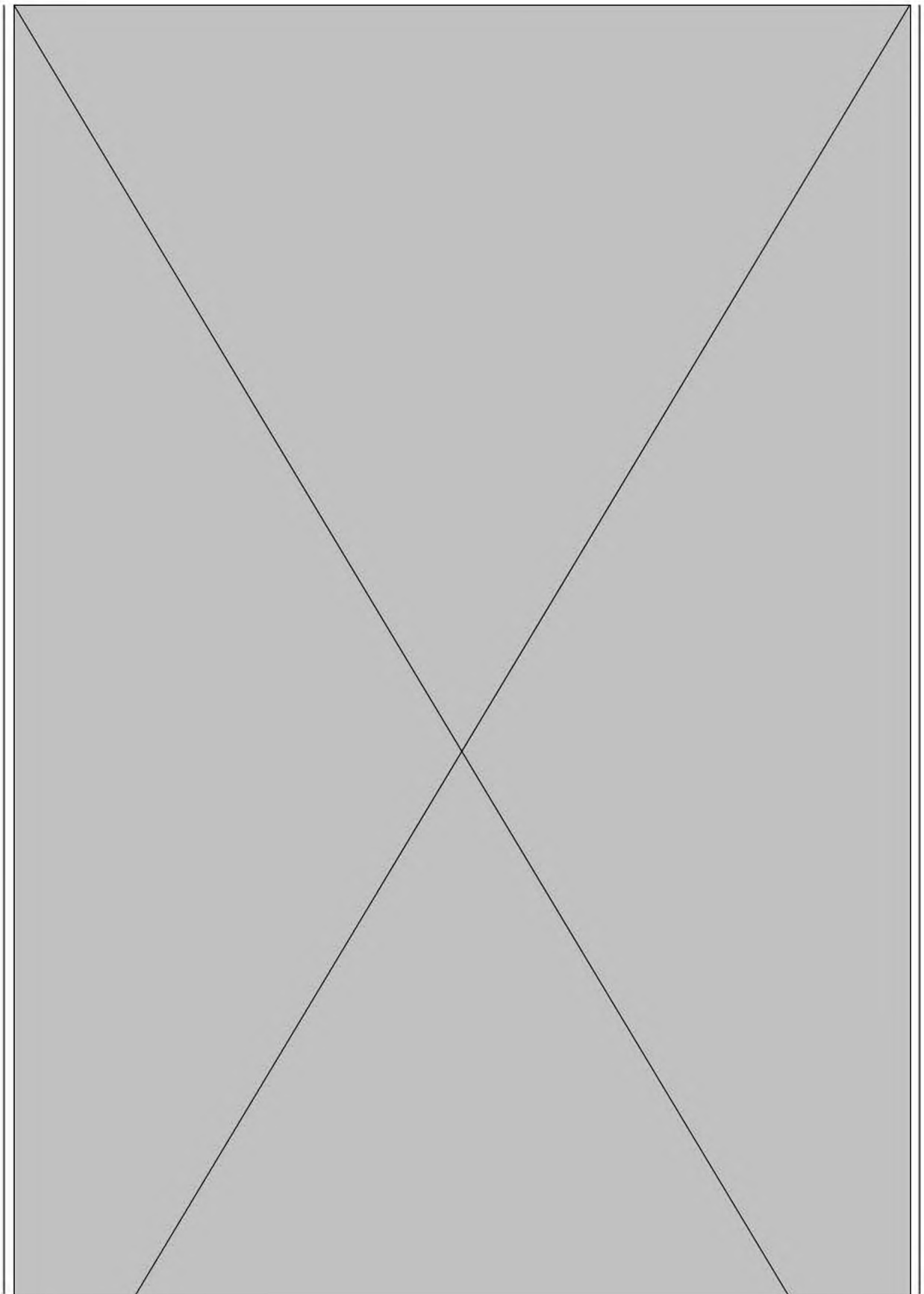
Here is the invite. I have also pasted the invite that was sent out below.
