Dear Doctor:

We have sent to you by parcel post urine and blood specimens which were collected from our employee, Mr. [REDACTED] on April 23, 1948. We would appreciate having a report on the lead level determinations as soon as possible.

Mr. [REDACTED] was first hired by this company on April 9, 1942. He is white, 50 years of age, 5'6 $\frac{1}{2}$ ", and weighs 127 pounds. Pre-employment examination: Heart and lungs O.K.; abdomen negative; reflexes O.K.; no hernia; blood pressure 108/80 and pulse 74.

He worked in our Plate Repair Department from the hire date until November 22, 1946 except for a period of a few months when he was in the Army and was discharged because of age. A separate chart of examinations and stippled counts from October 1944 to date is attached.

In August 1945 we requested a transfer to non-exposure work for him because of elevated stippling. Mr. [REDACTED] refused the transfer, stayed at home for ten days and came back to work on the same job. He stayed on this job then with moderate stippling until the department was abandoned in November 1946. He worked on a minimal exposure job from November 22, 1946 until April 21, 1947. His work from this date until April 1, 1948 has consisted in cutting lead pasted plates on a small circular saw or trimming plates on a foot shears.

Dust concentration in the Plate Repair Department in 1945 ranged from 0.44 to 3.13 mg in 10cc of air at various work positions. The concentration at his work from November 22, 1946 to April 21, 1947 was below .5 mg. At the saw position the concentration was 0.94 mg in January 1947. A previous reading on this job taken in April 1945 showed 14.1 mg. A reading at the shears in 1947 showed 5.94 mg which is the result of a lack of an efficient exhaust.

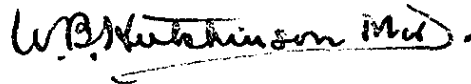

A transfer to non-lead was again refused by this man on April 2, 1948 and he has not worked since that time. He insisted that, as in 1945, a few days off would clear him up. He stated that his heavy drinking was as much the cause for stippled count elevation as was the lead. This case appeared to be one of lead absorption but because of his recent complaints we are reporting the case to the Industrial Commission.
