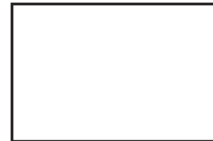

Further to our meeting earlier this year on the HLRT and “safe and sustainable by design”, I wanted to come back to you with an own initiative.

It is about GRA approach on ia. respiratory sensitizers announced in the [Inception impact assessment of the Chemicals legislation](#) – revision of REACH Regulation to help achieve a toxic-free environment.

As you might know our sector is using enzymes (Respiratory Sensitizers Category 1) as natural catalysts and we are very much concerned about the serious impacts of GRA on our sector and the sectors using our enzymes.

While we fully agree with efforts pursued with the revision, to increase efficiency of processes and reduce potential human and environmental exposure risks to chemicals, we believe the GRA approach is hindering innovation and the potential enzymes can bring in enabling the EU Green Deal.

Would you have any advice for us how we can discuss this in the HLRT and how we can address this topic in the best way?

In that regard, we wanted to share with you [how Corbion safeguards a sustainable supply chain](#) – which we deem very important to be able to use biobased sustainably.

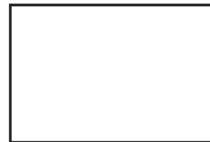
We also thank you for having indicated how to put the HLRT to even better use and feel specifically emboldened to do so through own initiatives, as you kindly indicated. We will come back to this.
