1 don't discuss the matter among yourselves or with
 2 anyone else, and please don't let anyone attempt to
 3 discuss it with you.
 4 See you tomorrow morning bright and early.
 5 Leave your pads right on your seats. Always
 6 leave them right on your seats.
 7 (Whereupon, jury dismissed -- 3:35 p.m.)
 8 THE COURT: Mr. McGowan, doesn't that remind
 9 you of --
 10 MR. McGOWAN: That is what I meant, the same
 11 thing.
 12 MR. WILLIAMS: Your Honor, in light of her
 13 comments, I just want you to know that your name did
 14 mean a lot when I went to get my temporary pass.
 15 MR. McGOWAN: Judge, it must be her daughter
 16 or her cousin or something.
 17 THE COURT: I don't know what it is, but we
 18 are blessed. We are blessed.
 19 MR. McGOWAN: Yes.
 20 THE COURT: Counsel, if you will be in your
 21 seats at 9:25, we will resume tomorrow morning at

1 9:30.
 2 Have a good evening, everyone.
 3 (Thereupon, at 3:36 p.m., the proceeding
 4 was adjourned.)
