Thank you for meeting with Peter Himchak, Dave Frulla and I early today to discuss Omega Protein, the Atlantic menhaden fishery, and the annual establishment of the Atlantic menhaden total allowable catch (TAC) by the Atlantic Menhaden Management Board. As discussed in our meeting Omega supports a science-based approach to setting annual quotas. We will continue to work with the FWS and all stakeholders to ensure that we sustain a healthy menhaden fishery.
