TO ALL DIVISION MANAGERS

Gentlemen:

We are sending you herewith the curves which are derived from the routine Ethyl field samples showing the number of samples over 3 c.c. and the average amount thereof. The amount of lead over 3 c.c. for the month of June shows a slight decrease now averaging 3.12. However, the percentage of samples showing heavy lead increased during the month to an alarming extent. Certainly when 9% of all the routine samples show more lead than the Surgeon General's regulation allows, it is time for us to give it every attention.

We are listing below the samples for the entire country which show heavy lead, and we wish you would analyse the samples for your division and let us hear from you on this subject.

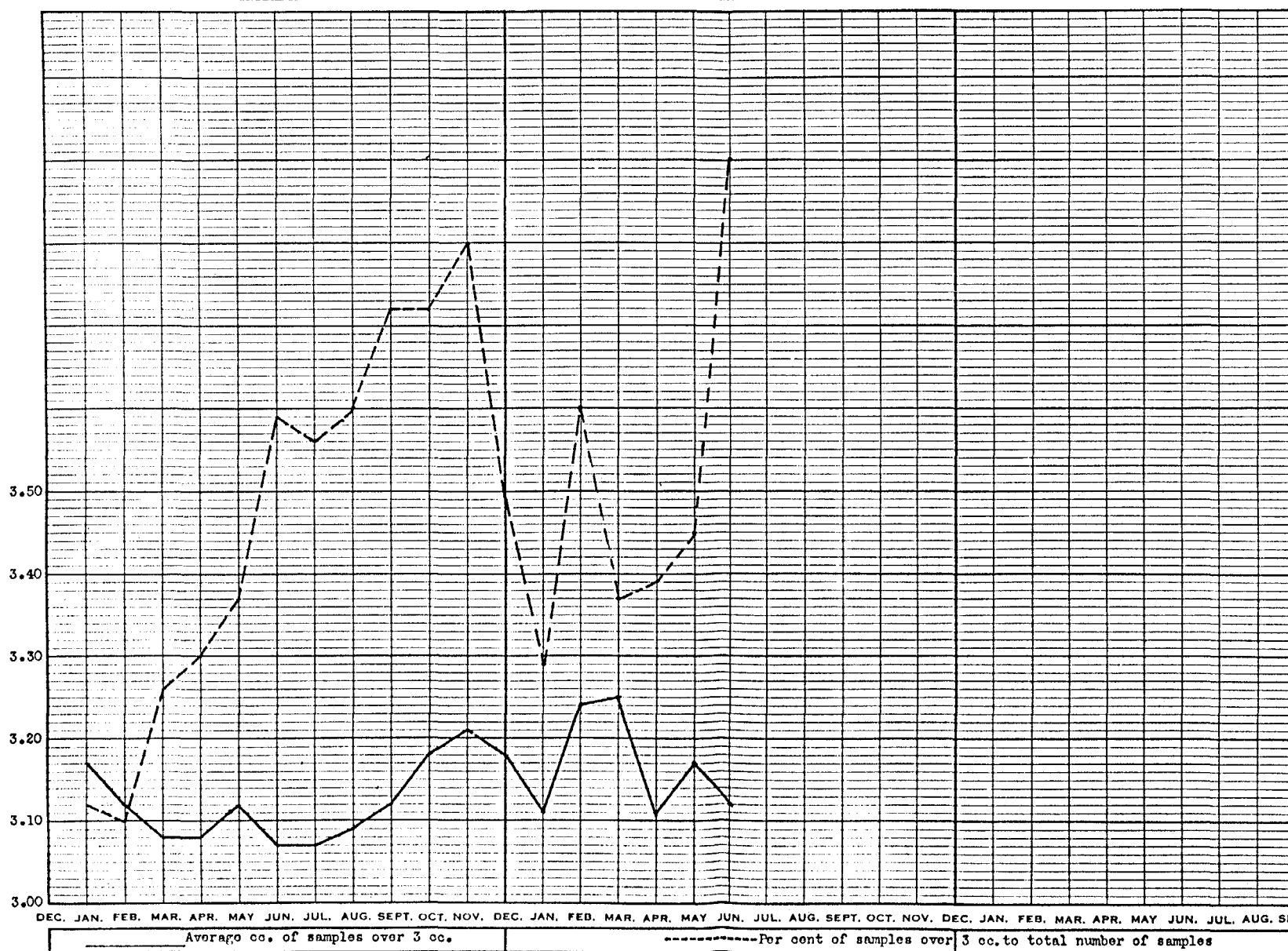
