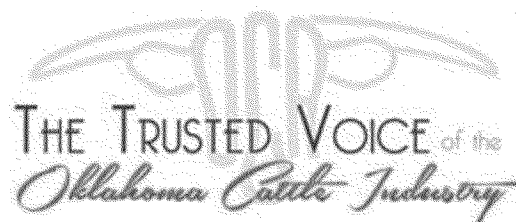
**Good Afternoon –**
