Dockers fear health peril from asbestos

DOCTORS and dockers employed by the Port of London Authority are in sharp disagreement over the health hazard involved in the unloading of asbestos cargoes at London Docks.

The dockers believe that present working conditions are unsafe—a view upheld by reports in the Sunday Times that a "new" and deadly tumour of the pleura can result many years after apparently brief exposure to asbestos dust.

Dr A. M. Lawrence-Smith, Principal Medical Officer of the P.L.A., has however made a controversial attempt to assuage their fears. In a signed statement circulated among the men he says that the Ministry of Labour arranged scientific investigations which excluded the lung disease of "asbestosis" as a risk to dock labour; that the development of the tumour associated with asbestos—known as mesothelioma—requires similar circumstances to those causing asbestosis; and that the tumour occurs only where a particular variety and grade of dust, not found in commercial cargo, is released into the air.

He has, he says, an assurance from H.M. Medical Inspectorate that the gangs run no risk of mesothelioma or asbestosis in handling such cargoes.

A spokesman of the Ministry of Labour, however, referred me to a letter on the findings of the Inspectorate, which has been sent to several interested parties. It reports that the concentration of air-borne dust was found to exceed the upper limits of safety when unlined hessian bags of asbestos are unloaded at the normal rate of working, and agrees that in such cases respirators should be worn.

The P.L.A. has in fact been supplying the men with masks and overalls for use when unloading asbestos and paying them an extra 2s. an hour for their trouble.

A world authority on mesothelioma, questioned by phone in Tokyo, where he was attending a cancer congress, considered that more than one of the P.L.A.'s pronouncements on this subject did not accord with the published facts.

Dr Robert Murray, medical adviser to the Trades Union Congress, said: "This is a misleading

Asbestos was gaping through holes in many more, made by the hooks which some dockers insist on using. Some of the men wore no respirator; others did so intermittently. A scientist who has tested the masks personally says it is hardly practicable to work in them for more than half-an-hour.

The solution is not merely a matter of masks but safer methods of packing and loading. That aspect of the problem is now exercising the ingenuity of doctors, scientists, and industrialists throughout the world.
