MARCH 13 - 14, 1984

The first quarters meeting of A.I.A./N.A. Board of Directors will be primarily devoted to a review and discussion of the regulatory initiatives of OSHA, EPA and Asbestos Information Associations response thereto. This will be the associations last meeting of the directors before the congressional hearings on the proposed revision to OSHA's asbestos standards are likely to occur. The thrust of this meeting should give us a fairly good handle on where OSHA and EPA are headed.

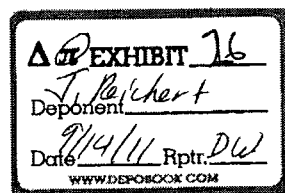
