PLANT SUPERVISORY PERSONNEL ATTEND SAFETY MEETINGS

All St. Helens plant supervisors attended safety meetings recently covering items such as house-keeping, safety suggestions, occupational health and environmental control, the safe handling of hazardous materials, personal protective equipment, fire protection and materials handling.

It was emphasized that a competent supervisor can eliminate, in a reasonable and efficient way, at least fifty percent of all unsafe acts and conditions by recognizing that most accidents are a result of human failure or mechanical failure. Continued employee education is necessary to eliminate both human and mechanical failures.

Also attending the meetings was Rex Hovey, the Oregon State Safety Inspector for this area. Mr. Hovey's topic was aimed primarily at the employee's role in carrying out a safety program. He emphasized that employees' attitudes and examples are the backbone of any good safety program.

Safety is a 24-hour day, seven day a week program. It involves all of us directly. The below rules are to be followed by every one of us in this plant:

- Always be alert for unsafe acts, practices, and conditions.
- Be alert to the indifferent employee, the one who takes the short cuts, who feels that safety rules are "kid stuff."
- Be consistent in following all safety rules and regulations.
- Report promptly all accidents no matter how small they may seem. This is so that small accidents do not become large ones.

Safety and health regulations are formulated for the purpose of protecting all employees. Because such regulations are in the best interest of everyone, no one can disregard them. Lost time accidents and subsequent work time loss creates suffering for the employee and family, loss of pay, and are costly to the company in terms of absenteeism.

CONTEST RULES FOR SAFETY BINGO

A new Safety Bingo incentive contest will begin on February 28, 1972, for all hourly employees. The plant will be divided into three accident prevention teams and each team member will receive a bingo card. Two numbers will be drawn weekly until there is a bingo in each team. The member getting the bingo should sign and date the card and return it to the Personnel Office or to his foreman. In the event of a tie "bingo" between two or more members of one accident prevention team, there will be a special drawing for high bingo number. A lost time accident occurring during the contest will terminate the contest.

The three accident prevention teams are: 1. Remanufacturing; 2. Wet Mill, Headrig, Yard Crew and Shipping; 3. Maintenance, A/C, Boiler Crew, Janitor, Sampleman and Painter. Rankings will be based on: (1) Housekeeping; (2) Safety Recommendations; (3) Accidents, (4) Unreported Accidents, and (5) Safety Violations.

SPEAKING OF SAFETY-----



As you are probably aware, this plant is presently on the verge of starting a very thorough hearing protection program. Our plant has been sound-surveyed twice in the past and as a result of these surveys it has been determined that hearing protection will be required in certain areas.

The Federal and State laws provide that hazardous noise areas are those areas that have a noise level of 91 dba's or above. These laws are designed to protect employees from permanent hearing loss. They also require a company to provide the necessary safeguards, thus insuring proper ear protection.

The safeguards that are or will be required by this plant are: one, the wearing of ear protection where designated; two, annual hearing examinations; three, where feasible, the engineering of equipment to reduce sound levels. Ear protec-

tion, prescribed to be worn, is the air cushioned ear plug. The ear plug is made of a soft rubber and is easily inserted in the ear with no discomfort to the wearer. The plugs are easily cleaned by merely washing them with soap and water.

Annual hearing examinations will be required commencing in the near future. The tests will be administered at the local hospital by competent and qualified personnel. The test will take approximately ten minutes and will be retained by the hospital for future referral information. The soundproof booth and the audiometer are being donated to the hospital for use by the community.

The purpose of audiometric testing is to detect small changes in hearing acuity and take necessary control measures before the small changes become hearing impairments.

The plant areas where hearing protection is designated to be worn are: the yard area around the air compressor; the scoop, the refiner area, between digesters, at the work bench, and at the control panels; the area around the forming machine; the tipple; the hot calender area; the tile lines and at the hog.
