The minutes of the previous annual meeting were approved.

The Report of the President was as follows:

#### REPORT OF THE PRESIDENT

The wisdom of having an association ready at short notice to tackle problems of common interest to the lead industries was illustrated repeatedly during 1935. The Lead Industries Association, as is shown by the Report of the Secretary, functioned in tariff matters and other government contacts smoothly and efficiently, saving a large amount of individual effort on the part of members in handling these important questions. Moreover, in the all too frequent outbursts of adverse publicity received by the lead industries, our Association was able to make prompt investigation and to have its views heard. Members have not hesitated to use the Association whenever a problem presented itself of more than individual interest. It is to be hoped that over a period of years the knowledge that an Association exists to defend the good name of lead will help greatly in decreasing the frequent and unwarranted attacks that are made on our industries, and which injure the market for various lead products.

The Association's affairs were economically managed during the year and it continues in a healthy financial position while its sphere of influence has been gradually extended.

The Secretary's report was read and approved as follows:

#### REPORT OF THE SECRETARY

During the second year of its existence the Lead Industries Association devoted its energies principally to the following activities:

(1) Statistics - Publication of an annual review of the statistics gathered by the Lead Industries Association was begun in 1935. Members were provided

with loose leaf binders for preserving all the Association's statistical data. In the last half of the year, collection and distribution of statistics showing the secondary lead, antimonial and soft, produced from old storage batteries was started, as well as stocks and receipts of old batteries. Our Association, so far as I know, is the first to begin the publication of current business statistics in the secondary metal field. We hope to expand the scope of the secondary metal report as rapidly as possible.

(3) Tariff - All our members are doubtless aware of the singular good fortune which attended our efforts to bring about a change in the drawback law permitting easier export of lead products from the United States by manufacturers. Not only were we completely successful in this effort, but we also succeeded subsequently in having the regulations of the Treasury Department, which are based upon the new law, modified to allow greater flexibility in the use of the drawback. For example, it is now possible for a fabricator of lead products to export from any branch regardless of its domestic geographic location against an importation of lead at any other branch. We are still endeavoring to procure a change in the Treasury Department's recent and important regulation whereby the drawback period extends from the date of importation of the foreign lead into the United States rather than (as heretofore) from the time of withdrawal from warehouse, a regulation diminishing the period during which the drawback may be used. Up to the passage of the Hawley-Smoot Tariff bill on June 17, 1930, much time was given to guarding our interest in this legislation. Although no change was made in any lead rate, the Senate, at one time, unexpectedly reduced the tariff on lead pigments, but, by prompt action, the Lead Industries Association was able to make its views known to the Senate and succeeded in obtaining a restoration of the old rate.

(3) Other Government Contracts - During 1931 the Federal Trade Commission issued a complaint against the use of the name Leadite for a product containing no lead, but the company manufacturing this product has elected to stand trial and it will be some time before the case is settled.

We have urged the Federal Government to change its specifications for pig lead, Federal Standard Specification No. 117, Grade A, so that it will conform to general trade practice.

We have also succeeded in getting the Treasury Department to give consideration to the use of lead covered skylights in government contracts and are taking steps to see that lead is not discriminated against in government work.

(4) Education and Publicity Efforts - The Lead Industries Association began the publication, in November, of a bulletin entitled "Lead" to be issued six times a year. The bulletin (circulation 18,000) is designed to be distributed among architects, sheet metal workers, plumbers, master painters, decorators and others to provide them with information regarding new and old uses of lead. The bulletin has received a happy reception and numerous of its items have been reprinted in technical and other magazines. It has already helped the sale of some lead products. The Lead Industries Association is also supplying many magazines with articles of special editorial interest.

Although the publication of the book, "Useful Information About Lead" has been delayed, the manuscript and value of the book has been greatly improved. It is expected to appear some time this Spring.

(5) Research - During the year we entered a co-operative and competitive research of protective pipe coatings for petroleum lines buried in the soil in co-operation with the Bureau of Standards and the American Petroleum Institute, but the result of this investigation will not be available for several years. Our entry was red lead baked upon pipe prior to the application of the secondary or finishing coat. This test is similar in many respects to that begun in 1936 by the American Gas Association, which we also helped to support.

We are also experimenting with the use of lead in eliminating cracking of ice cakes in the refrigeration industry.

(6) Lead Poisoning - We have continued to support the medical research at Harvard University under Dr. Aub, through the generosity of some of our members who are particularly interested in this important work.

(7) Adverse Publicity - Throughout the year occasional outbursts of publicity detrimental to lead, practically all of it unwarranted, appeared. In each case which the Association discovered, a thorough investigation was made, with a view to taking whatever action might be proper under the circumstances. Through prompt investigation of each instance, it is hoped that we shall ultimately be able to stop some of the seemingly ceaseless propaganda appearing in the press inimical to the lead interests and that we shall be able in some measure to protect the good name of lead.

The Chairman stated that it was in order to elect directors for the current year.

It was moved and seconded that the Secretary, cast one ballot for the outgoing board of directors, who, being eligible, offer themselves for re-election, except that B. N. Zimmer shall replace Julius Loeb, retired, as representative of the American Metal Company on the board.

Motion carried.

The Secretary outlined the difficulty in obtaining figures covering lead pipe and sheet from one dealer and suggested that by combining the sheet and pipe figures it might be possible to obtain the desired statistics.

It was moved and seconded that lead sheet and pipe figures be combined until further action.

Motion carried.

It was also moved and seconded that the Association's reports of Mixed Metals and Blue Lead Products should be placed on a monthly instead of weekly basis in order to facilitate gathering the figures.

Motion carried.

It was further recommended that the Association should attempt to gather figures covering the intake and production of secondary lead from all sources.

The Secretary outlined some problems in connection with the proper use of lead service pipe in municipalities which must require collective attention of the lead pipe manufacturers and the Industries Association at a later date, particularly, as it related to the size of the pipe. He explained that

an additional report would be made later to the members.

The drastic inroads in the lead foil business made by competitive organic materials was also mentioned by the Secretary, and one member suggested that research might be conducted in an effort to compare the merits of various types of wrappings on tobacco and related products under practical conditions. The President recommended that all possible information be obtained.

The situation with respect to white lead was discussed, and the opinion was expressed by several members that the efforts at publicity for lead products already made by the Association were a step in the right direction and that it was hoped the Association's publicity would grow.

The meeting adjourned at 2:15 P.M.
