Dear Mr. Lewis:

It will interest you to know that we finally have some light on the Cleveland cases.

We have completed the analyses of the samples from the Texas Company at Lockport, Illinois, sent to us by Ben Crane and the results are quite high. All of the samples show evidence of marked contamination with litharge, the total lead content being above 20% and the organic and presumably volatile lead content is also quite high.

In view of Crane's statement as to likelihood of draw-off of sludge in barge loading, this will furnish us with a partial explanation at least as to the source of the lead in the Cleveland tanks.
