I am enclosing a copy of a letter and its enclosure which I recently received from Mark Granger, Goodrich's counsel.

With respect to the question whether any separate Monsanto entity may have supplied Monsanto's Indian Orchard plant in Springfield with vinyl chloride, the Monsanto answers in the Cullinan case stated that "The Springfield plant was also supplied with VC monomer internally from Monsanto's Texas City plant."

Perhaps one of your production people would know whether the Texas City plant was at any time in the last 25 years owned or operated by a Monsanto subsidiary rather than by Monsanto itself. If need be, possibly this information can be gleaned from the
