Budget Reassessment - items not included in UCHSC, AHS or Fudan reassessments (courtesy of Rob Schnatter):

1) EMBSI: \$1,208.4K total budget (add to UCHSC / EMBSI subcontract)

1,208.4K = 884K original + 324.4K additional for Yimei Zhou 2006 (12 months at 75% time)

---- Yimei 2007 included in original \$884K budget estimate (6 months at 40%)
---- Yimei 2006 was offered as XOM "sweat equity" contribution
---- Yimei 2005 provided by ExxonMobil (12 months at 75%)

2) UCHSC: \$60.0K additional for this new item (add to UCHSC)

60.0K to collect and analyze toluene (T), xylenes (X) and ethylbenzene (eB) data

---- Exposure Reconstruction: collect T/X/eB data from IPHS for comparison to benzene records
---- T/X/eB not regulated for workplace exposures, providing cross-reference for benzene data
---- T/X/eB co-exposure may alter benzene metabolism & urinary metabolite excretion (e.g., SPMA)

3) UCHSC: \$478.8K additional for these items (add to UCHSC / Fudan subcontract)

\$478.8K = 50K + 25K + 135.2K + 45K + 100K + 56K + 67.6K for Shanghai support

50K to extend Dr. Ni's contract to locate ME phase 1 and 2 factories

(a) contract expired 3/31/05, and additional factories need to be recruited.

25K for additional western-based expert review of job exposure matrix

(a) retain funds in "contingency" for EA effort?
(b) apply to EMBSI sub-contract?

135.2K for 4 additional Shanghai-based EA staff (US\$16,900/year) x 2 years

(b) one additional staff to work with IPHS to extract data info from IPHS database;
(c) two additional skilled staff (with leadership skills) for field work;
(d) one factory liaison (from district IPHS office) to work with municipal IPHS for factory recruitment.

45K for additional Factory Access (based on experience to date, US \$1K – 2.5K per factory)

(a) 15 factories for Phase 1 (\$1K);
(b) 12 factories for Phase 2 (\$2.5K).

100K for 8 Chinese industry experts (e.g. printing, painting, rubber)

(a) 100K = 8 x \$50/hr x 125 hr/year x 2 years;
(b) note: this represents a 4x decrease from Dr. Fu's earlier proposed requirement.

56K to further engage district IPHS offices

(a) district offices are administratively separate from Municipal IPHS;
(b) funds provided to Municipal IPHS was not further distributed to district offices.

67.6K for two EA liaisons, to facilitate ex-Shanghai IPHS & factory communications

(a) 67.6K = 2 liaisons x 2 years x US\$16,900/year.
