I am writing to you from H&M Group to express our support for a swift revision of the REACH Regulation. I would also like to share our recently finalized position paper on the issue.

For our company, the REACH revision is essential to ensure predictability and favorable conditions for the proactive chemicals management. We need a strong chemicals law to meet our consumer safety and circular economy goals.

In the attached position paper, we are describing how textile brands, such as ours, will benefit from the ambitious REACH revision. We are also giving recommendations for the implementation of the generic approach to risk management and calling for the improvement of chemical transparency.

We would like you to ask the Commission to deliver the REACH proposal until June 2023. It is crucial that the REACH revision is dealt with by the sitting Parliament.
