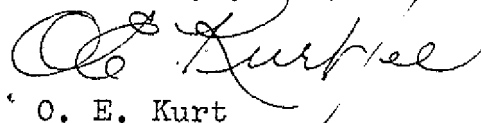

The agenda for the meeting of February 9 and February 10, 1955 is as follows: No additions have been suggested to the preliminary agenda of January 6, 1955.

Wednesday - February 9 at 2:00 p.m. in the Library

1. Air Pollution (Dr. R. A. Kehoe and D. A. Hirschler)

a. General aspects (Dr. R. A. Kehoe)

- (1) Review of the smog problem as it exists in Los Angeles- characteristics of smog, conditions that favor its occurrence, theories on its cause, the contribution of engine exhaust and waste refinery gases, and the interest of the petroleum and automotive industries.
- (2) Toxicological problems - overall problems, hydrocarbons and combustion products, chemical reactions in the atmosphere, particulate matter such as lead, inhalation and metabolism of lead.
- (3) Problems associated with use of TEL.

b. Specific aspects (D. A. Hirschler)

- (1) Relationship of Ethyl activities to work of other organizations - West Coast groups, API, CRC.
- (2) Experimental program at Detroit, nitrogen oxide, exhausted lead.
- (3) Developments by automotive industry.

2. Antiknock Fluid Stability (C. C. Shepherd)
 - a. Decomposition in commercial "Ethyl" fluid - field and plant experience and accelerated laboratory test results.
 - b. Competitive fluid stability - laboratory test results.
 - c. Effect of antioxidants on fluid decomposition - laboratory tests and drum storage test results.
3. Amine Antiknocks (J. E. Brown)
 - a. Amines as TEL supplements.
 - b. Theoretical explanation of effectiveness of primary and secondary aromatic amines.
 - c. The antiknock effectiveness of amines as substantiated by road tests.
 - d. Though not competitive with TEL, interest remains high as evidenced by West Coast sales of NMA, inquiries from small refiners and consideration at joint technical conferences with major oil companies.
4. Octane Requirement of 1955 Automobiles (H. A. Toulmin)
 - a. The octane requirements of the entire population of U.S. automobiles and significant segments of it.
 - b. Methods used in predicting octane requirements of new model cars - Ethyl road tests, road tests of CRC contributors, and data released by car manufacturers, and evaluation of these data.
 - c. The relationship between predicted OR of 1955 automobiles and present and future octane levels of premium and regular gasolines.

The following preliminary agenda is submitted for the meeting to be held on Thursday, February 10, 1955.

1. Amine Antiknocks - Research work has been terminated. Brief resume of the relationship between antiknock effectiveness and molecular structure; detailed economic evaluation including the cost of the more promising amines, possible sources, possible value to refiners; presentations being made in Joint Technical Meetings with customer companies.
2. Fluid Stability - Comprehensive report on the comparison of the fluid storage stability and gasoline storage stability of Ethyl fluid; comparison with competitor's product.
3. Air Pollution - Ethyl's studies of the past several years of lead in engine exhaust gases; Ethyl's participation in committee activity on the contribution of engine exhaust gases.
4. Octane Requirement of 1955 Automobiles - The result of Ethyl's tests together with information obtained by consulting with automobile manufacturers; new automobiles with low mileages and some with enough mileage to indicate the octane requirement increase.
5. Sales Program for 1955 - A report by Mr. Frey to a larger group, including supervisors, on the Sales program as presented in a Sales meeting during the previous week. Suggestions as to how R & E may best support the 1955 program and future sales programs.

This preliminary agenda is submitted to aid members of the committee in suggesting other subjects or certain aspects of the above listed subjects; also in deciding what persons should attend and what preparation they should make to participate in the discussions.
