Dear Doctor Radtke:

I have not been unmindful of your telephoned request of me to keep my ear to the ground and to recommend to you, if possible, someone who might be able to fulfill the requirements which you outlined to me, in your quest for a successor to Don Fowler. I have not had much success in carrying out your wishes until a few days ago, when I learned that one of our graduates, who has a position in Cincinnati but would not be unwilling to accept an enlarged professional opportunity, might be available.

I write to you somewhat hurriedly, so far as my present ability to do anything further about this matter is concerned, since I am going to London and on to a conference in Amsterdam on a problem of some mutual interest - an effort to develop some definitive for professional performance in the European lead trades. One of my trusted associates here has spoken to this man and has established his willingness to consider your job, if this can be done (as of course it can be) without compromise to his present status.

The man is Jerome F. Cole, who received his degree (Sc.D. in Occupational Health) here. He is a young, vigorous and enthusiastic man with a distinct flair for research. This is his reason for looking beyond his present position, which is in Industrial Hygiene in Procter and Gamble, in association with P & G's Medical Director, and extremely competent physician who also is an earlier graduate of our Institute, and who therefore, had access to first-hand information about our crop of industrial hygienists. We think highly of him and I think he could handle your job ably. He will grow into a sound, dependable man with good scientific instincts and breadth of knowledge. There are certainly other men who are equal to the task, and it may be that I can come upon one or more other persons, whom I can recommend to you. I would be prepared, of course, to be of such help as I might, in matters related to lead, and to research and practice in that relationship.

I shall call Dr. Cole tonight or tomorrow - or as soon as I can reach him, to tell him that I have written to you, and that he may hear from you. I shall not commit you to any action in his direction, and indeed I would await word from you before speaking to him, but for the fact that I shall be out of reach for the next two
