Dear Gerry:

In reference to your letter of December 8, 1978, I am attaching an idealized version of our industrial hygiene organization. At the present time the Administrator's job is vacant which means that our five field hygienists (we're looking for another one) report to me. With everything that is taking place today, I find our present set-up something less than ideal.

Responsibility for plant industrial hygiene programs rests with the plant. That is the reason for our dotted line relationship with plant hygienists as shown on the organization chart. The responsibility of the corporate headquarters group is to assist plants in establishing programs appropriate for their needs, and to audit the programs to assure their adequacy and consistency. The headquarters group also provides technical back-up for the plants and may conduct special studies primarily of corporate interest.

As regards meeting their industrial hygiene needs, we believe that our plants should be self sufficient insofar as their resources will allow them. Ultimately, we can envision full time hygienists in perhaps seven of our larger, more complex plants. (We're working toward this end now. The present count is one full time plant hygienist and a second one authorized.) These plants and many of our smaller plants have adequate laboratory facilities to enable them to take care of most of their routine industrial hygiene analyses. Although our corporate industrial hygiene laboratory is concerned primarily with sampling and analytical development work, it also may help our plants in doing those analyses (usually non-routine) they are unable to do.

In the medium size plants, industrial hygiene will have to be a part time responsibility. The responsible person will wear at least two hats (e.g. industrial hygiene and, most usually, laboratory, sometimes air and water pollution as well). It is essential that those doing industrial hygiene work at the plants be adequately trained. The number of problems a plant will have and the depth of training their "hygienists" have will determine how much loving care they will receive from the corporate group.

The small plants very seldom can afford the luxury of having in-house industrial hygiene capability. Most of their needed work will have to be done by the corporate hygienists. If need be, local personnel can be trained to do the bare minimums (e.g. handle a detector tube, hang a sampling pump on an employee, or know when to cry for help).

In the above I've tried to provide you with our over-all philosophy and a broad view of our organization. However, there are a lot of other ways to skin this cat, and I've mentioned nothing about pros and cons of any of these. There is so much that could be said about the over-all topic that any written response may very well provoke more questions than it answers. If I managed to do this to you, I think clarification might be accomplished at a face-to-face session. Should this appear attractive to you, I would welcome the opportunity.

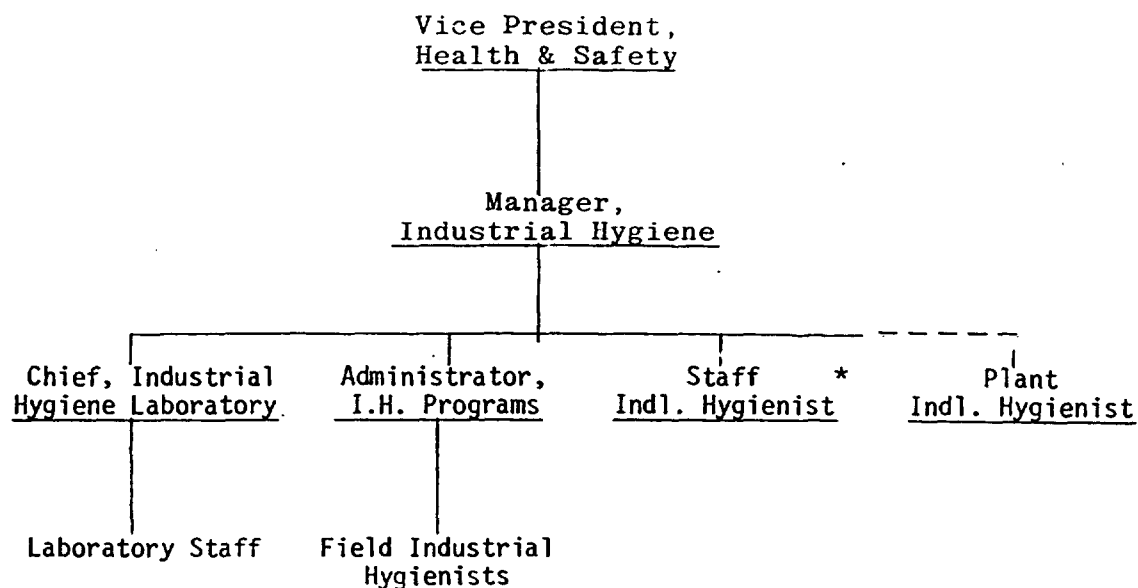

PREFACE
CHEMICAL CONTAMINANTS

Threshold limit values refer to airborne concentrations of substances and represent conditions under which it is believed that nearly all workers may be repeatedly exposed day after day without adverse effect. Because of wide variation in individual susceptibility, however, a small percentage of workers may experience discomfort from some substances at concentrations at or below the threshold limit; a smaller percentage may be affected more seriously by aggravation of a pre-existing condition or by development of an occupational illness.

Tests are available (J. Occup. Med. 15: 564, 1973; Ann. N.Y. Acad. Sci., 157, Art. 2: 968, 1968) that may be used to detect those individuals hypersusceptible to a variety of industrial chemicals (respiratory irritants, hemolytic chemicals, organic isocyanates, carbon disulfide).

Three categories of Threshold Limit Values (TLVs) are specified herein, as follows:

a) Threshold Limit Value-Time Weighted Average (TLV-TWA) — the time-weighted average concentration for a normal 8-hour workday or 40-hour workweek, to which nearly all workers may be repeatedly exposed, day after day, without adverse effect.

b) Threshold Limit Value-Short Term Exposure Limit (TLV-STEL) — the maximal concentration to which workers can be exposed for a period up to 15 minutes continuously without suffering from 1) irritation, 2) chronic or irreversible tissue change, or 3) narcosis of sufficient degree to increase accident proneness, impair self-rescue, or materially reduce work efficiency, provided that no more than four excursions per day are permitted, with at least 60 minutes between exposure periods, and provided that the daily TLV-TWA also is not exceeded. The STEL should be considered a maximal allowable concentration, or ceiling, not to be exceeded at any time during the 15-minute excursion period. STELs are based on one or more of the following criteria: (1) Adopted TLVs including those with a "C" or "ceiling" limit. (2) TWA-TLV Excursion Factors listed in Appendix D. (3) Pennsylvania Short-Term Limits for Exposure to Air-

borne Contaminants (Penna. Dept. of Hlth., Chapter 4, Art. 432, Rev. Jan. 25, 1968). (4) OSHA Occupational Safety and Health Standards, 40 FR 23073, May 28, 1975. (5) NIOSH criteria for recommended standards for occupational exposure to specific substances. The TWA-STEL should not be used as engineering design criterion or considered as an emergency exposure level (EEL).

c) Threshold Limit Value-Ceiling (TLV-C) — the concentration that should not be exceeded even instantaneously.

For some substances, e.g., irritant gases, only one category, the TLV-Ceiling, may be relevant. For other substances, either two or three categories may be relevant, depending upon their physiologic action. It is important to observe that if any one of these three TLVs is exceeded, a potential hazard from that substance is presumed to exist.

The TLV-TWA should be used as guides in the control of health hazards and should not be used as fine lines between safe and dangerous concentrations.

Time-weighted averages permit excursions above the limit provided they are compensated by equivalent excursions below the limit during the workday. In some instances it may be permissible to calculate the average concentration for a workweek rather than for a workday. The degree of permissible excursion is related to the magnitude of the threshold limit value of a particular substance as given in Appendix D. The relationship between threshold limit and permissible excursion is a rule of thumb and in certain cases may not apply. The amount by which threshold limits may be exceeded for short periods without injury to health depends upon a number of factors such as the nature of the contaminant, whether very high concentrations — even for short periods — produce acute poisoning, whether the effects are cumulative, the frequency with which high concentrations occur, and the duration of such periods. All factors must be taken into consideration in arriving at a decision as to whether a hazardous condition exists.

Threshold limits are based on the best available information from industrial experience, from experimental human and animal studies, and, when possible, from a combination of the three. The basis on which the values are established may differ from substance to substance, protection against impairment of health may be a guiding factor for some, whereas reasonable freedom from

irritation, narcosis, nuisance or other forms of stress may form the basis for others.

The amount and nature of the information available for establishing a TLV varies from substance to substance; consequently, the precision of the estimated TLV is also subject to variation and the latest Documentation should be consulted in order to assess the extent of the data available for a given substance.

The committee holds to the opinion that limits based on physical irritation should be considered no less binding than those based on physical impairment. There is increasing evidence that physical irritation may initiate, promote or accelerate physical impairment through interaction with other chemical or biologic agents.

In spite of the fact that serious injury is not believed likely as a result of exposure to the threshold limit concentrations, the best practice is to maintain concentrations of all atmospheric contaminants as low as is practical.

These limits are intended for use in the practice of industrial hygiene and should be interpreted and applied only by a person trained in this discipline. They are not intended for use, or for modification for use, (1) as a relative index of hazard or toxicity, (2) in the evaluation or control of community air pollution nuisances, (3) in estimating the toxic potential of continuous, uninterrupted exposures or other extended work periods, (4) as proof or disproof of an existing disease or physical condition, or (5) for adoption by countries whose working conditions differ from those in the United States of America and where substances and processes differ.

Ceiling vs Time-Weighted Average Limits. Although the time-weighted average concentration provides the most satisfactory, practical way of monitoring airborne agents for compliance with the limits, there are certain substances for which it is inappropriate. In the latter group are substances which are predominantly fast acting and whose threshold limit is more appropriately based on this particular response. Substances with this type of response are best controlled by a ceiling "C" limit that should not be exceeded. It is implicit in these definitions that the manner of sampling to determine noncompliance with the limits for each group must differ: a single brief sample, that is applicable to a "C" limit, is not appropriate to the time-weighted limit; here,

a sufficient number of samples are needed to permit a time-weighted average concentration throughout a complete cycle of operations or throughout the work shift.

Whereas the ceiling limit places a definite boundary which concentrations should not be permitted to exceed, the time-weighted average limit requires an explicit limit to the excursions that are permissible above the listed values. The magnitude of these excursions may be pegged to the magnitude of the threshold limit by an appropriate factor shown in Appendix D. It should be noted that the same factors are used by the Committee in determining the magnitude of the value of the STELs, or whether to include or exclude a substance for a "C" listing.

"Skin" Notation. Listed substances followed by the designation "Skin" refer to the potential contribution to the overall exposure by the cutaneous route including mucous membranes and eye, either by airborne, or more particularly, by direct contact with the substance. Vehicles can alter skin absorption. This attention-calling designation is intended to suggest appropriate measures for the prevention of cutaneous absorption so that the threshold limit is not invalidated.

Mixtures. Special consideration should be given also to the application of the TLVs in assessing the health hazards which may be associated with exposure to mixtures of two or more substances. A brief discussion of basic considerations involved in developing threshold limit values for mixtures, and methods for their development, amplified by specific examples are given in Appendix C.

Nuisance Particulates. In contrast to fibrogenic dusts which cause scar tissue to be formed in lungs when inhaled in excessive amounts, so-called "nuisance" dusts have a long history of little adverse effect on lungs and do not produce significant organic disease or toxic effect when exposures are kept under reasonable control. The nuisance dusts have also been called (biologically) "inert" dusts, but the latter term is inappropriate to the extent that there is no dust which does not evoke some cellular response in the lung when inhaled in sufficient amount. However, the lung-tissue reaction caused by inhalation of nuisance dusts has the following characteristics. (1) The architecture of the air spaces remains intact. (2) Collagen (scar tissue) is not formed to a

significant extent (3) The tissue reaction is potentially reversible.

Excessive concentrations of nuisance dusts in the workroom air may seriously reduce visibility, may cause unpleasant deposits in the eyes, ears and nasal passages (Portland Cement dust), or cause injury to the skin or mucous membranes by chemical or mechanical action per se or by the rigorous skin cleansing procedures necessary for their removal.

A threshold limit of 10 mg/m³, or 30 mppcd, of total dust < 1% quartz, or, 5 mg/m³ respirable dust is recommended for substances in these categories and for which no specific threshold limits have been assigned. This limit, for a normal workday, does not apply to brief exposures at higher concentrations. Neither does it apply to those substances which may cause physiologic impairment at lower concentrations but for which a threshold limit has not yet been adopted. Some nuisance particulates are given in Appendix E.

Simple Asphyxiants — "Inert" Gases or Vapors. A number of gases and vapors, when present in high concentrations in air, act primarily as simple asphyxiants without other significant physiologic effects. A TLV may not be recommended for each simple asphyxiant because the limiting factor is the available oxygen. The minimal oxygen content should be 18 percent by volume under normal atmospheric pressure (equivalent to a partial pressure, pO₂ of 135 mm Hg). Atmospheres deficient in O₂ do not provide adequate warning and most simple asphyxiants are odorless. Several simple asphyxiants present an explosion hazard. Account should be taken of this factor in limiting the concentration of the asphyxiant. Specific examples are listed in Appendix F.

Physical Factors. It is recognized that such physical factors as heat, ultraviolet and ionizing radiation, humidity, abnormal pressure (altitude) and the like may place added stress on the body so that the effects from exposure at a threshold limit may be altered. Most of these stresses act adversely to increase the toxic response of a substance. Although most threshold limits have built-in safety factors to guard against adverse effects to moderate deviations from normal environments, the safety factors of most substances are not of such a magnitude as to take care of gross deviations. For example, continuous work at temperatures above 90°F, or overtime extending the workweek more than 25%, might be consid-

RE: RESPONSIBILITIES OF INDUSTRIAL HYGIENISTS
EMPLOYED BY INDUSTRY

1. Primary responsibility is to protect the health of the employee.
This responsibility cannot be compromised.
2. The hygienist also has a responsibility to protect and serve the interests of his employer. Contrary to some popular thinking, we believe that these two responsibilities are completely compatible. Where incompatibilities do, in fact, exist, we believe they are due to unenlightenment or unethical practices on the part of the Industrial Hygienist and/or his company.
3. The Industrial Hygienist must carry out his responsibilities in a moral, legal, ethical, and objective manner.

Specific responsibilities to the employer are:

1. See that employees are properly protected.
2. See that the company is operating within the requirements of the law.
3. The hygienists' recommendations must consider the economic health of the company. (This is the greatest challenge of an Industrial Hygienist employed by industry. He, in cooperation with Operating personnel, must not only achieve a healthy

working environment... but must achieve it by the most economical means. If he is successful at this, he has helped the company to also achieve a competitive edge. This aspect of Industrial Hygiene is unique to industry. Industrial Hygienists from government or from consulting organizations need not be concerned about the economic impact of their findings or recommendations.)

4. The hygienist is obliged to carry out his responsibilities according to the highest moral and ethical principles.
5. All of his recommendations must be objectively based on the best available information. He must consciously attempt to prevent subjectivity from shading his judgment. If unsuccessful at this, he risks the chance of losing his credibility should his subjective reasoning prove to be wrong.

Policy -- For Each Plant

1. All workplace contaminants will be kept to the lowest levels practicable.
2. Employee exposures to workplace contaminants shall not exceed the legally established limits, or those established by Alcoa's Industrial Hygiene Division. Where the applicable legal and Alcoa limits differ, the lower limit will apply.

Written Program

Every plant having need for Industrial Hygiene activity must have a written program.

The program must clearly describe:

1. The policy and objectives of the program
2. The areas in the plant that have potential health problems
3. The specific Industrial Hygiene activities required to accomplish the program objectives

There are several reasons why the program should be in writing:

- A plant manager is responsible for knowing all activities being carried out in his plant... and keeping them in balance. A written program satisfies this "need to know".
- A written program also provides concrete evidence that employee health is of concern to Alcoa. Such evidence is of use and interest to managers, employees, the union, the public, and the government.
- Put in writing, it assists the hygienist to optimize his cost effectiveness in that a periodic review of the document requires that he adjust his priorities in accord with changes in plant activities or outside stimuli (e.g., new regulations, revelation of previously unknown hazards, etc.). The written document also prevents the hygienist from overlooking plant activities that should be carried out.

- Finally -- and of great importance -- a written program provides continuity that can otherwise be lost when there are changes in personnel.

The contents of a typical written program are shown in Table 1.1.

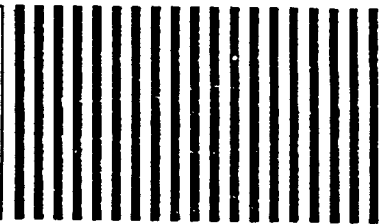

NOTE: RESPIRATORY PROTECTION IN PRIMARY ALUMINUM PRODUCTION

This note has been prepared by a Panel of the Health Committee of the International Primary Aluminum Institute under the authority of the Board of Directors of the Institute. It is intended to provide guidance regarding the selection of respiratory protection for our members involved in primary aluminum production.

Primary aluminum production, utilizing the Soderberg process, employs a self-baking anode immersed in a cryolite bath. Volatile resinous materials, particulate polycyclic organic matter (PPOM), are released into the potroom during this self-baking process from the coal tar pitch binder used in the anode mix. This hydrocarbon release does not generally hold true, however, for the pre-bake potrooms, since these hydrocarbons are removed in the carbon plant during the anode baking cycle. Hydrocarbon emissions in the pre-bake potrooms do occur during cathode bake-out, but this operation is quite limited.

A number of epidemiological studies has shown an association between exposures to PPOM and cancer in the workplace. (1,2,3,4,5,6) As a result, consideration has been given to the use of respiratory protection in potroom and carbon plant operations where hydrocarbon exposures occur in order to minimize employee exposure.

Since there are no current governmental approvals for respiratory protection against PPOM, several investigations concerning respirator efficiency have been carried out by member companies. (7,8) Results appear in the attached tables.

NOTE: RESPIRATORY PROTECTION IN PRIMARY ALUMINUM PRODUCTION

As can be seen from the data, most of the respirators tested achieved collection efficiencies of at least 90 percent (protection factor of 10). Accordingly, employees wearing any of these respirators will be protected against elevated PPOM exposures of up to 10 times the current Standard. Respirators with lower collection efficiencies will, of course, provide correspondingly lower protection factors.

In addition, other studies were carried out to determine the collection of efficiency of the 3M #8706 respirator for volatile organic matter, sulfur dioxide, and fluoride. (9) Results of this effort indicate collection efficiencies of 41 and 51 percent for volatile hydrocarbons and sulfur dioxide. Collection efficiencies for gaseous fluoride were 96-100 percent and particulate fluoride 93-99 percent, thereby providing an overall collection efficiency of 95-99 percent for total fluoride. While exposures to these irritants are generally quite low, the #8706 respirator can be used to provide added comfort and protection.

RE: RADIATION SURVEY - ROCKDALE WORKS

Enclosed is the radiation survey report from Applied Health Physics, Inc., Bethel Park, PA, relating to the release of naturally occurring radioactive materials from the lignite mining and power generation operations at the Rockdale Works.

The survey showed that radioactive contamination was low... well below established allowable limits. The findings were consistent with those of a number of recent studies showing that releases of radioactive material from power plants fired by similar fossil fuels were well within the limits of radiation protection guides set forth by the Federal Radiation Council, the International Commission on Radiological Protection, and Part 20 of Title 10 of the Code of Federal Regulations.

The report contained two recommendations for further study which we feel are not supported by the technical issues involved. One referred to the collection of additional ambient air quality data. The other referred to an evaluation of the distribution and uses of ash that is sold. Although the ambient air sampling study was of limited duration (17 days), the findings were consistent with rather extensive and conclusive studies of similar operations. We have no evidence to indicate that the Rockdale operation is uniquely different than those studied in depth.

The possibility that the sale of the ash would be a source of potential liability to Alcoa is likewise remote. In order to estimate the degree of risk to which users of the ash could be subjected, we calculated the radiation level that would be in a heavy dust cloud of 15 mg/M^3 (this is the highest level of workroom contamination permitted by OSHA). The dust cloud was assumed to consist solely of fly ash, the material having the highest radiation level -- 8.91 pCi of uranium per gram. A 15 mg/M^3 dust cloud of the fly ash will result in a radiation level of $1.34 \times 10^{-13} \text{ } \mu\text{Ci/cc}$. This concentration is only 2.8% of the NRC permissible limit for natural uranium -- $5 \times 10^{-12} \text{ } \mu\text{Ci/cc}$. Or, from another viewpoint, an intolerably heavy dust cloud of 560 mg/M^3 , greatly in excess of OSHA's nuisance dust limit, would be required before the NRC radiation limit would be reached. We believe the likelihood of workers being regularly exposed to dust clouds of this magnitude is extremely remote.

RE: ALCOA PERMISSIBLE EXPOSURE LIMITS

In the United States there exist at least four lists of numbers relating to concentrations of environmental contaminants that are considered "safe" levels of employee exposures. These are:

Permissible Exposure Limits	OSHA
Threshold Limit Values.	ACGIH
Recommended Concentrations.	NIOSH
Acceptable Concentrations	ANSI

For any given material, it is conceivable that each of the four organizations could provide us with a different number. This can be a source of distraction to the professional industrial hygienist. To those in our plants who are less informed about industrial hygiene it can be completely bewildering. Therefore, if any of us in our correspondence have occasion to cite any two or more limits to plant personnel, we must tell them which limit they must observe. On the other hand, unless it is absolutely essential, we should resist the temptation to quote more than one limit.

Within Alcoa, we will adhere to the OSHA PEL's. There are two exceptions to this:

- (1) When no OSHA limit exists for a contaminant, or
- (2) When we believe the OSHA limit is too high.

In the case of these exceptions, it is essential that all of us recommend the same limits to our plants. Whenever you feel that we should observe a limit other than OSHA's, first consult with Bob James. He will be the person responsible for making exceptions.

Should there be a sufficient number of exceptions, it is prudent for us to generate a list and distribute it to our plants. These exceptions should consist only of those materials that are found in our operations (i.e., there is no need for us to critique the complete list of PEL's). If you have candidates for a list of exceptions, please submit them to Bob James, who will coordinate this activity.

RE: POTENTIAL EXPOSURES DURING POT SHELL REPAIR

Hourly employees of the Point Henry Operations described two potential exposures encountered during pot repair of which I was not previously aware. They stated that they frequently encountered tarry material in the bottom of the pot shell. This causes them concern since welding of the shell is a common occurrence in pot repair operations. If true, this means that during pot use the volatiles are not completely baked out of the cathode.

They also wondered about the composition of corrosive material that also is found in the shell. Their complaint is that it is "irritating, eats steel, and puts holes in their clothing."

Are you aware of the existence of either of these potential problem areas? If not, would you check with your plants to determine if they have encountered these problems? It may even be worthwhile to check with pot repair personnel when you next visit your smelters. Should we confirm either of these situations, we would be well advised to develop a set of recommended precautionary procedures applicable to all of our smelters.

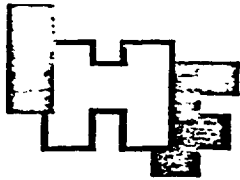

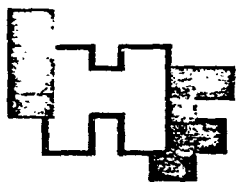

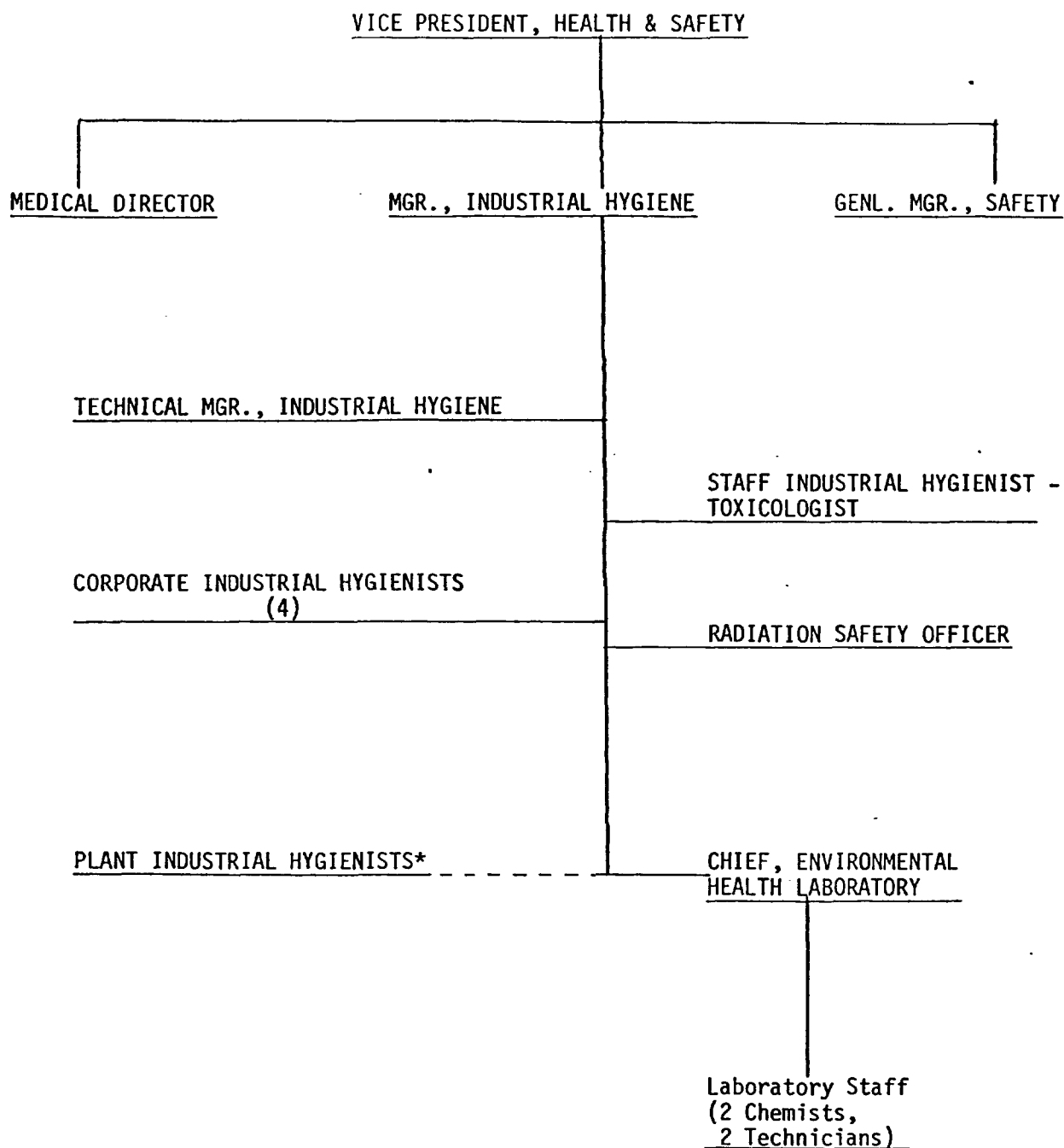
