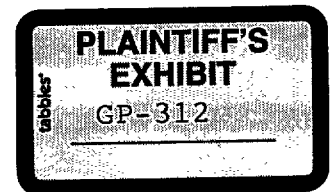

Pursuant to your recent request, please allow the following to serve as supplementation to Georgia Pacific's Response to Interrogatory Number 21 in the Dallas In Re Interrogatories:

21. Identify by name and location each plant or manufacturing facility in which the products listed in your answers to Interrogatories Nos. 3-6 were manufactured, assembled, or prepared for sale or marketing, specifying which plants produced each item, the dates each plant is or was in operation, and the time span during which each named item was produced or manufactured.

ANSWER: The plant in Acme, Texas has been operated by Bestwall Gypsum Company or Georgia-Pacific from 1956 through the present. At various times, and intermittently during the time frames indicated in this response, the plant manufactured Ready Mix (66-p), Joint Compound (56-77), Bedding Compound (57-p), Topping Compound (59-p), All Purpose Joint Compound (56-p), Triple Duty Joint Compound (65-p), Speed Set/One Day (63-p), Central Mix (70-73), Texture (59-p), Patching Plaster (62-75), Spackling Compound (66-71), Lite Acoustic (61-64), or Kalite (56-59), in addition to many products that did not contain asbestos at any time. The above referenced products ceased to contain asbestos at various times, though Georgia-Pacific introduced and continues to sell asbestos free formulations of many of these products.

The Akron, New York plant has been operated by Bestwall Gypsum Company or Georgia-Pacific from 1956 through the present. At various times, and intermittently during the time frames indicated in this response, the plant manufactured Ready Mix (64-p), Joint Compound (64-77), Bedding Compound (63-p), Topping Compound (63-75), All Purpose Joint Compound (63-p), Triple Duty Joint Compound (unknown-p), Texture (63-p), Kalite (56-59), Lite Acoustic (59-62), Laminating Compound Ready Mix (69), or Drywall Adhesive (72), in addition to many products

The above referenced products ceased to contain asbestos at various times, though Georgia-Pacific introduced and continues to sell asbestos free formulations of many of these products.

The Fort Dodge, Iowa plant has been operated by Bestwall Gypsum Company or Georgia-Pacific from 1956 through the present. At various times, and intermittently during the time frames indicated in this response, the plant manufactured Ready Mix (65; 81-p) or Lite Acoustic (59-62), in addition to many products that did not contain asbestos at any time. The above referenced products ceased to contain asbestos at various times, though Georgia-Pacific introduced and continues to sell asbestos free formulations of many of these products.

The Grand Rapids, Michigan plant has been operated by Bestwall Gypsum Company or Georgia-Pacific from 1956 through the present. At various times, and intermittently during the time frames indicated in this response, the plant manufactured Lite Acoustic (58-62), in addition to many products that did not contain asbestos at any time.

The Sigurd, Utah plant has been operated by Bestwall Gypsum Company or Georgia-Pacific from 1956 through the present. At various times, and intermittently during the time frames indicated in this response, the plant manufactured Lite Acoustic (59-62), in addition to many products that did not contain asbestos at any time.

The Brunswick, Georgia plant has been operated by Bestwall Gypsum Company or Georgia-Pacific from 1959 through the present. At various times, and intermittently during the time frames indicated in this response, the plant manufactured Ready Mix (67-81), Joint Compound (67-77), Bedding Compound (71-81), Topping Compound (67-76), All Purpose Joint Compound (67-81), Triple Duty Joint Compound (67-81), or Texture (67-81), in addition to many products that did not contain asbestos at any time. Each of the above referenced products ceased to contain asbestos at various times, though Georgia-Pacific introduced and continues to sell asbestos free formulations of many of these products.

The Marietta, Georgia plant has been operated by Georgia-Pacific from 1969 through the present. At various times, and intermittently during the time frames indicated in

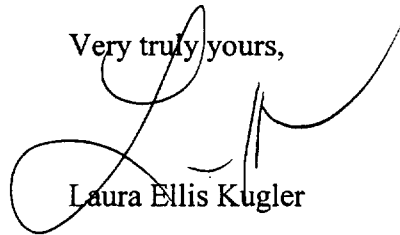

this response, the plant manufactured Ready Mix (69-p), Joint Compound (69-77), Bedding Compound (69-p), Topping Compound (69-75), All Purpose Joint Compound (70-p), Triple Duty Joint Compound (69-p), Central Mix (71-73), or Texture (69-p), in addition to many products that did not contain asbestos at any time. The above referenced products ceased to contain asbestos at various times, though Georgia-Pacific introduced and continues to sell asbestos free formulations of many of these products.

The Milford, Virginia plant has been operated by Georgia-Pacific from 1973 through the present. At various times, and intermittently during the time frames indicated in this response, the plant manufactured Ready Mix (73-p), in addition to many products that did not contain asbestos at any time. Each of the above referenced products ceased to contain asbestos at various times, though Georgia-Pacific introduced and continues to sell asbestos free formulations of many of these products.
