Meeting was called to order at 12:15 P.M.

Minutes of the previous meeting of November 20, 1956 were approved.

SURVEY OF INDUSTRY TECHNICAL ACTIVITIES

The committee received a recommendation from the Technical Steering Committee that an appropriation of \$20,000 be made for a six month technical survey to be made by the Battelle Memorial Institute.

In the discussion it was brought out that, while the Technical Steering Committee had voted unanimously in favor of accepting the Battelle Memorial Institute proposal, there had been some disagreement as to the relative merits of the Battelle and the Arthur D. Little, Inc., proposals. Since the members of the Industry Development Committee had not had an opportunity to talk to their representatives on the Technical Steering Committee, it was suggested that the Industry Development Committee recommend to the Board of Directors an appropriation of \$20,000 for a technical survey, leaving the final decision as to whether to accept the Battelle proposal or the Little proposal to the Industry Development Committee after its members had had an opportunity to discuss the proposals with their representatives on the Technical Steering Committee.

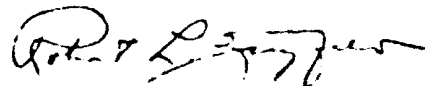
April 25, 1957
