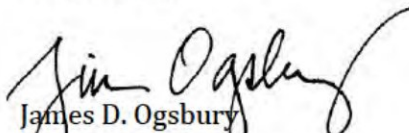
Western Governors invite you to deliver a keynote address and engage with them on issues within the jurisdiction of the Department of the Interior.
