Soviet Union, the United
dom and the United States did
not mention the Japanese peace
treaty. This was natural, for the
war with Japan was then in
full vigor and the Soviet Union
was then neutral in that war.

The Council of Foreign Ministers can, of course, deal with "other matters" than the European matters specified but only "by agreement between the member governments."

The United States has not agreed and does not agree to the reference to the Council of Foreign Ministers of the matter of making a Japanese peace treaty. The reason, among others, is that the systematic inclusion in the Council of veto power militates against the speedy achievement, through the Council, of an early peace treaty. Furthermore, the proceedings of the Council would give a secondary role to allied powers which bore a greater burden of the Pacific war than did the Soviet Union.

Interests of China Reflected in Profit

The government of the Soviet Union urges that the peace making procedure should fully take account of the interests of China in a Japanese peace treaty. The procedure being presently followed does that. It is true that the United States does not seek
