IV. TECHNICAL

A. WAXED EXTRUDATES

The second round of trials on the Bepex Extractor is scheduled for the week of July 9 in Santa Rosa, Ca. Bepex has indicated that if the equipment proves suitable, they could toll-produce for us on an interim basis in Minneapolis, Mn.

This is being pushed as top priority, in view of the sale of Envirostrand to Associated Lead.

B. GEORGIA- PACIFIC (ETHYL)

The customer has stated that their test method is the same as that used in Bridgewater. We therefore have no explanation for the gross differences in results obtained. We will consult with Bridgewater Tech service regarding the reproducibility of the test.
