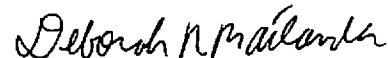
Regarding your letter as to deposition schedule for the remainder of this week, we accept your offer to postpone the Carolyn McFarland deposition and we are unilaterally postponing the remainder of those depositions ourselves.

In regard to the Wills deposition, we are not aware of when we last discussed the matter that Westinghouse was moving for a protective order in regard to a document with Mr. Wills' name on it. Also, your new motion for a protective order regarding the attorney investigations into the alleged discussion of evidence makes it impossible for us to go through with the remainder of the depositions on that issue until the Judge rules on your attempt to withhold those reports.
