DAY - 2 -

A second trip was made to the landfill site of Washington County on April 25, 1974. The Space Center trucks (3m's) were observed and data was recorded. Again the author was sampling and checking for typical 3M scraps, atypical scraps, and handling problems either would present.

Results follow this. Ssmple and pictures will be included in the report once they're analyzed and developed.

Observation:

1. 3M scraps quite a few jumbo rolls of film, paper, abrasives, etc. that pose handling problems (explained earlier).
2. The dumped powders present problems in that they become irritants to the operators-etc.
3. Fe_2O_3 (untreated) dumped by 3M may be a pollution problem in a landfill if in great enough quantities.
4. The landfill is tentatively scheduled to close August 1st.
