Per our prior discussion, I think the information contained in the reports could be of value for our litigation; but it must be in a usable form.

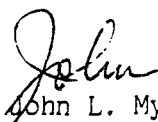
There are less than 400 individual reports so a mechanical summary may be more practical than using a computer. I would suggest a separate listing of all reports in three different categories, as follows:
