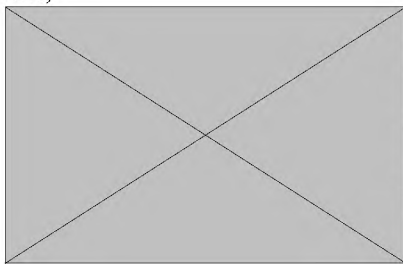

Secretary Zinke's remarks would be prior to a panel discussion entitled, "Innovation to Drive the Energy Industry Forward." The entire focus of our Friday session (s) relates to the opportunity for innovation to drive the natural gas industry forward over the coming decades. All of our keynote sessions and through our closing luncheon session are really focused on the future and what happens next.

Secretary Zinke is being asked to deliver 10 minutes of remarks, at 8:30 am, prior to a panel discussion taking place. The Secretary would not be expected to be part of the panel, and he would be able to leave the Convention Center immediately after his remarks, should he so desire. Clearly, the innovations developed by the US gas industry have been critical in making this incredible transformation of the industry.

With the panel following the Secretary focused on innovative aspects in a wide variety of areas, not always totally related to the gas industry, we believe that Secretary Zinke's remarks would really set the stage for understanding the role that natural gas, and in particular US natural gas, can play in "driving the energy industry forward."

I hope this is helpful and will help in convincing Secretary Zinke that the opportunity to speak at the first World Gas Conference in the United States in 30 years is a unique one. It will be decades before this event returns to the United States.
