Hospital Insurance Shifted to Texas

With the approval of bargaining representatives of seagoing employees, the basic hospital-surgical-medical insurance coverage is being transferred from Health Service, Inc., Chicago, to Blue Cross-Blue Shield of Texas, in Dallas. It is expected that the change will result in better case handling and more prompt payment of benefits.

All seagoing employees who are subscribers to this insurance will receive new identification cards to be used instead of the Health Service, Inc. cards, which should be destroyed provided you have no claims for service prior to Aug. 1.

There is no change in benefits or the procedure for making claims *except* to substitute Blue Cross-Blue Shield of Texas, Main at North Central Expressway, Dallas, Texas 75222 wherever Health Service, Inc. is mentioned in the Medical Expense Program booklet.

There is also no change in the major medical coverage, which continues with the Travelers Insurance Co.

TYPES OF HOSPITAL-MEDICAL INSURANCE

This seems a good time to review the various

classifications of hospital-surgical-medical and major medical coverage. There are 5: individual: individual and one dependent: family: sponsored dependent, or spouse only (under age 65) in the case of an annuitant who is 65 or over. Whenever your family status changes from one type of coverage to another, the Company should be notified so that you get the insurance you need and pay the correct premium.

Perhaps the least understood type of coverage is the sponsored dependent. An unmarried child becomes a sponsored dependent when he reaches age 19. This can go on until he reaches age 23 unless he becomes self-supporting sooner. A conversion to sponsored child coverage must be filed with the Company at least one month before the child attains age 19.

Also on the subject of dependents — how about your Thrift Fund and life insurance beneficiary designations? Are they the way you want them, or do you know how they are? Members of the Benefits and Claims Section have been (and still are) having personal interviews with men aboard

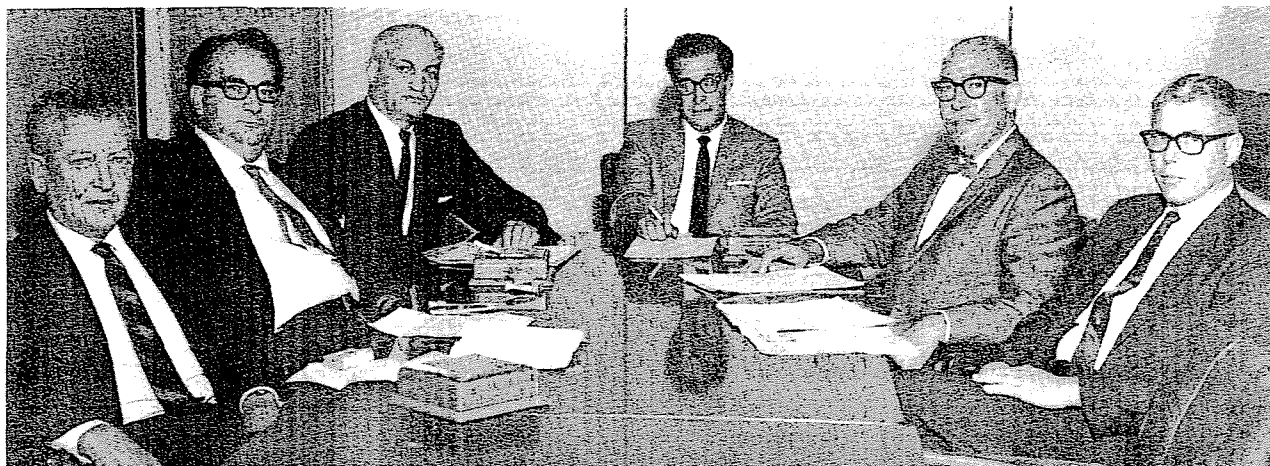

tanker operating prospects on the West Coast, the Middle East situation, new ship plans, seniority, and various shipboard work rules. The Company offered to increase its share of the hospital-surgical-medical premiums. More basic negotiation points were not brought up due to an ESA request to meet in the New York area so they could have

"benefit of counsel." It is expected that negotiations will resume in a few days.

During the first meeting, Joseph Andrae, General Manager, and Sydney Wire, Asst. General Manager, "dropped in to say hello" and wish the negotiators success in producing a mutually satisfactory agreement.

Total donations from the Fleet amounted to \$1,624.35, the highest of any U. S. Flag fleet, including many with more ships and more seagoing personnel.

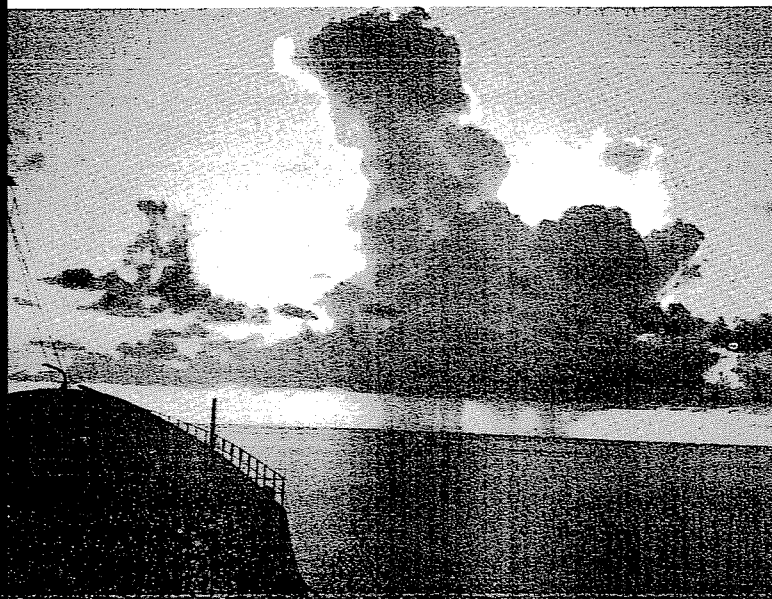
It may be of some interest to know that the Company also made a contribution to the Library — somewhat more than the total from the Fleet.

Esso Newark Back From the 7* Seas

The *Esso Newark* docked at Baytown, July 30, becoming the second Company tanker to complete a round-the-world voyage in July. (The *Esso Miami* was the first.)

The *Newark's* 100-day circumnavigation began from Baytown, April 21. She sailed from Baton Rouge, April 23, transited the Suez Canal, May 11-12 and discharged her lube oils at Bombay, May 20 to June 2. The Middle East crisis was hot when she arrived at Bahrain, June 6 and she didn't get away until the 16th — and that included 9 days' war bonus for the crew.

The Bahrain cargo was discharged at 3 ports in Okinawa, July 1-5, followed by the long haul across the Pacific to the Panama Canal, transited July 26-27.

RECENT RETIREMENTS



2ND ASST. ENGINEER CHARLES E. HOLTON figures the transition from employee to annuitant will hold no problems for him. He sees retirement as continuous paid leave and plans to do what he has been doing on his regular leaves. That means taking care of his home in Charleston, S. C.; doing a few chores for Elsie, his wife, and scooting off across the country on his motorcycle. (Charlie is an ardent cyclist from way back.)

After some engine dept. service with Clyde Mallory Lines in 1937 and '38, Mr. Holton shipped out as Pumpman, Third and Second Asst. with Esso in 1939 and '40. He returned to the Fleet in Aug. 1948 as Second Pumpman and has served as an engineer officer since Dec. 1949. For the past 2½ years he has been Second and

First Asst., sailing most recently in the former rank aboard the *Esso Houston*. He retired (early) Aug. 1 with 20 years' service.

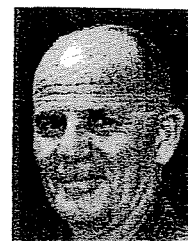


CHARLES E. SCHWARB, senior Radio Officer in the Fleet, relinquished his position Aug. 1 to get in a little extra time as an annuitant. What he will do with the time he has not yet decided but it will likely involve electronics, travel and Siamese cats.

Mr. Schwarb's 38 years of credited service began when he signed on in the *W. C. Teagle*, July 28, 1927. It was a short assignment but he was back the next year for 7 months in the *Walter Jennings* and from May 1929 on, his service was continuous. It included 7 years in the *G. Harrison Smith*, wartime voyages in the *Esso Bayonne*, *Christy Payne* and *Wallace E. Pratt* and, since June 1954, over 11 years in the *Esso Bangor*. For 10 years (1954 to '63) he was a member of the EROA negotiating committee.

Prior to joining the Company, Mr. Schwarb shipped out in a Socony tanker, a Shipping Board freighter and worked at the FADA radio plant and the Ritz Carlton Hotel in New York City. He and his wife Ethel are long-time residents of Manhattan.

RADIO OFFICER CHARLES E. WARREN, JR. sampled a half-dozen U. S. shipping companies in the 1930s before deciding to pound out the dots and dashes in the radio shacks of Esso tankers. He was Radio Officer in 4 vessels between July 1937 and Oct. 1940 and after 2 war-time years with the Army Transport Service, returned to the Fleet in Jan. 1945. Since then he has been "Sparks" in the *Esso Roanoke* for 3 years, in the *Esso Scranton* for 7 and the *Esso Florence* from 1958 until his retirement, July 1. He joins the early annuitant ranks with 25 years' service.

MAINTENANCE MECHANIC / SECOND PUMPMAN THOMAS BOYLE retired on disability July 1. Following his first assignments in the Fleet as Wiper in the *Charles Pratt* and *G. Harrison Smith* in

1935 and '38. he was FWT. Oiler and Pumpman in 8 vessels during World War II. His service, totaling 21 3/4 years, was intermittent since the War but continuous as Oiler and MM/2P since June 1963.

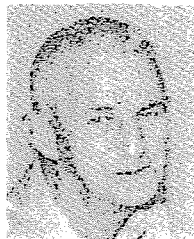
Upon receipt of the statement, it is suggested that you

- Work out the retirement income estimate to see how the Annuity Plan applies in your own case. This is not difficult in most instances.

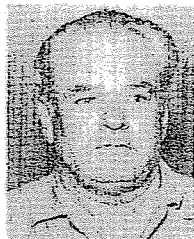

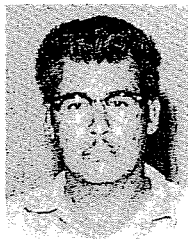
