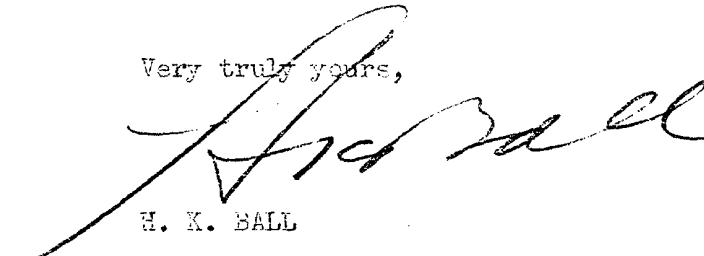
"Will you please pass this on to Dr. Kehoe and ask that he advise Eastern Airlines.
