By now most of you have probably heard about the recent Executive Order that revoked the November 3, 2015, Presidential Memorandum *Mitigating Impacts on Natural Resources from Development and Encouraging Related Private Investment*.

And you have likely heard about the March 29, 2017, Secretarial Order 3349 *American Energy Independence*, which revokes SO 3330 *Improving Mitigation Policies and Practices of the Department of the Interior*.

Several of you have contacted me to ask what this means. I don't have any information for you at this time, but wanted to let you know that we are following the direction in SO 3349 and compiling a list of actions related to the Presidential Memorandum and SO 3330. I'll keep you updated as we go through the process described in SO 3349.
