I think the letter that came to me needs to be edited. Mr. Sanch is requesting one additional year pursuant to Clean Air Act (CAA) § 112(i)(3)(B) and 40 C.F.R. § 63.6(i). Because those are site-specific requests, they should be made to the delegated permitting authority, usually the state or if the state hasn't taken delegation, the EPA Regional office. But that is not the only way they can seek an exemption. The Administrator's Great American Comeback announcement stated that sources could seek a 2-year compliance waiver under the Presidential Exemption. I just got info a few minute ago from PACS on the name of the EPA mailbox set up to receive these requests. We need to also include this information in the letter. And then finally, as the letter currently states, the Administrator also announced that EPA intends to reconsider the rule.
