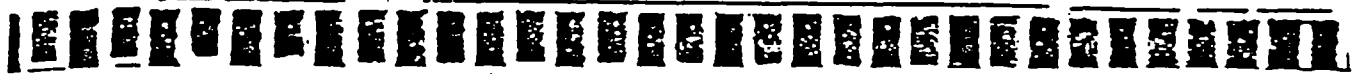

Clay Industry Gets Good Treatment At Minimum Wage Hearing



HEARINGS on the proposed minimum wage for the structural clay products industry under the Walsh-Healy Act were held in Washington, D. C., March 26, before the Public Contracts Board of the Wage and Hour Division of the United States Department of Labor. No definite action was taken due to a request from the A. F. of L. for permission to file a brief on collective bargaining wage contracts, following which the Board permitted 30 days for such action.

Thirty-five individual manufacturers,

representatives of the United Brick and Clay Workers Union of America and the Labor Committee of the Structural Clay Products Institute attended the hearing, which was conducted under the direction of Major Robert Campbell and O. R. Strackbein.

Major Robert Campbell, examiner for the Public Contracts Board, stressed, on two separate occasions, the excellent cooperation extended by SCPI in its work of gathering and classifying data for the present hearing. He also expressed appreciation

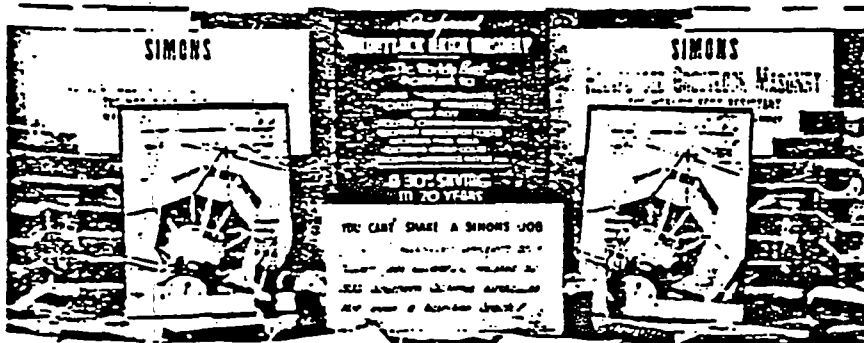
for the time given by the SCPI Labor Committee, composed of George A. Bass, of St. Louis, Mo.; Paul B. Belden, of Canton, Ohio, and Robert H. Gamble of Jacksonville, Fla., in a comprehensive study and survey of the wage structures maintained in the clay products industry. Louis A. Gravelle, of the law firm of Sanders, Gravelle, Whitlock and Howrey, Washington, D. C., legal counsel of SCPI, was congratulated on the work he had done in collaboration with John Klingensfeld, head of the Research Section of the Division of Public Contracts, Department of Labor, in assembling the questionnaire data submitted for examination and consideration.

Since the passage of the Walsh-Healy Act, June 30, 1936, some 200 industries have had the wage provisions of the Act applied to them and it was a case of unusual recognition on the part of a Federal Government agency that SCPI was requested to work out the details of applying the wage provisions of the Act to the structural clay products industry.

SCPI Works Out Wage Application

On May 5, 1938, Mr. Klingensfeld got in touch with the Institute, requesting that a discussion be held. Mr. Gravelle immediately took the matter under study and held several conferences with Mr. Klingensfeld. Further action was suspended until after the annual convention of SCPI, at which time the Labor Committee of the Institute was appointed. On February 23, 1939, the Labor Committee met with L. Metcalfe Walling, Administrator of the Walsh-

This window display in the Architects' Building, Los Angeles, Calif., was set up by Simons Brick Co. in conjunction with the Curtis Publishing Co. Its purpose was to counteract possible reflections on the clay products industry from an article, "Shakes," published in the Saturday Evening Post, in which earthquake damage was referred to in connection with a hollow tile and brick high school of faulty design and construction. The display demonstrates the "shakeproofness" of reinforced Groutlock brick masonry at the time of the 1933 Southern California earthquakes. Setting up this display in an engineer's and architects' office building before the article came out was an especially well-chosen bit of promotional work.
