

ORIGINAL INVESTMENTS
IN TITANIUM PATENTS

On Dec. 31, 1937, 5,000 shares of common stock of The Sherwin-Williams Company was given in exchange for the patents and property of the Burgess Titanium Company. (This exchange was approved by the Board of Directors on December 14, 1937.) On December 31, 1937 - the date on which the exchange was consummated, Sherwin-Williams Common Stock sold on the New York Curb Exchange at a price of \$84.00 per share - book value was \$55.77.

The transaction was recorded at the par value of common stock - 5,000 shares at \$25.00 per share, or \$125,000.00.
