It may take another couple of working days due to the fact that, although we have already identified them, they contain personal data and we need to process delete such data in order to offer you full access to the information of public interest therein.

With regard to the deadline, kindly note that, in accordance to the Romanian Law no. 544/2001 for access to public interest information and in view of the large number of documents, the accurate date when the legal deadline lapses is 30 days from the day following [the registration of] your request (also the day the deadline lapses is also from the 30 days period). [This is due to the fact that the Permanent Representation is not one of the European Institutions that fall under the scope of the Regulation 1049/2001.]
