- (ii) The Indentors being aware that the goods are to be shipped by our foreign principals to terms of this indent, it is expressly agreed that Messrs Indmag Limited, Delhi will not in any way be liable or responsible for any damage, loss, cost, charges and expenses, claims or demands whatsoever in case there is late shipments, part shipment non-shipment or non-arrival of the goods comprised in this Indent.
- (iii) The shipment time specified is subject to shipping facilities being available and to strikes and/or other causes 'Force Majeure'. Shipment may be made in one or more lots at the option of the suppliers and each shipment shall be treated as a separate contract.
- (iv) The charges for freight, Insurance, import duty, clearing and landing when included in the price, based on the rates prevailing at the date of this indent. All increase in the freight, Insurance, import duty, clearing and landing after the date of this indent will be on account of the indentor. This indent if not returned by the indentor duly accepted by them to Messrs Indmag Ltd., within 10 days from the date of despatch to the indentor, will be treated as null and void. Any acceptance of this indent after the expiry of the said period of 10 days will be subject to the confirmation of Messrs Indmag Ltd.
