Dear Bob,

Many thanks for your letter of June 7, which reached me only today. Our postal service at present is all at sixes and sevens, due to letter bomb scares and Civil Service unrest, following the election of our new government, which has proposals to reduce our vast number of Civil Servants to a more manageable level.

As regards the Ventolin, we were more than pleased to be able to get this for you and no question of payment arises. The paper you sent us under separate cover, arrived about a week before your letter and I agree is a very good summary of your studies. As I was reading through it, it seemed to me I had read it before and sure enough, on checking with our Medical Department library, I found we had a copy which either you had sent to me, or I had picked up from you, in 1966. If you are short of copies I shall send this one back to you, but otherwise would prefer to keep it here.

I do not think I really have the temerity to either advise you or offer critical comment on the way in which you propose to set out your data. However, I agree that tables and illustrative figures of the data for each subject should be produced and, if possible, made out in such uniform way as to afford comparisons between subjects. Differences between the subjects, such as race, age, height, weight, metabolism, ventilatory capacity, medical and social histories, including academic abilities, and any other differences that might have been noted at the time, would be of value for inclusion, on the basis that such differences may, in some way, have influenced the metabolism of lead. You have, of course, a great profusion of data and the prime difficulty is going to be in condensing it all in such a way as to present a report which, while
