The S&H Green Stamp incentive program to reduce blood lead levels will be discontinued effective January 1, 1980.

In its place the following will be incorporated to become effective January 1, 1980.

Any employee who is required to wear a respirator thru the entire work shift will be given a \$50.00 gift certificate when the results of the latest blood lead sampling show his level to be below 0.050.

This applies to the routine blood sampling which means an employee can earn up to six awards per year.
