



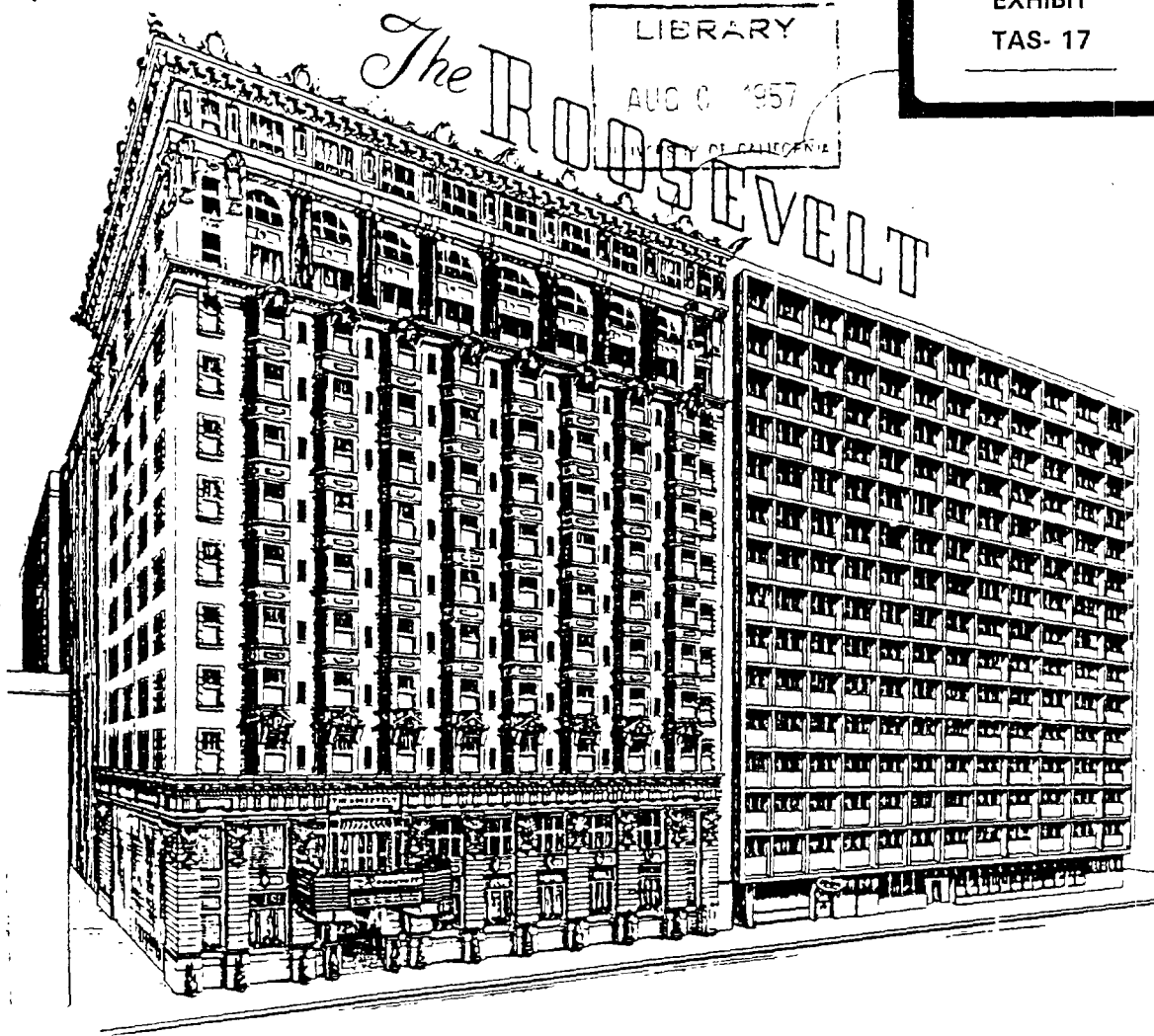

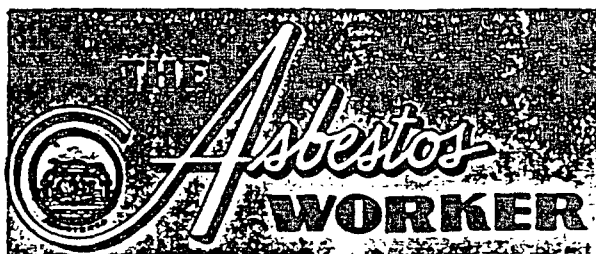

Some Facts About YOUR COVER PICTURE

THE HOTEL where celebrities stay—that might well describe The Roosevelt, New Orleans' finest hotel.

From the far corners of the world, crowned heads, including an emperor, ambassadors, generals, cardinals, the great names of stage and screen, come to The Roosevelt.

Since the hotel opened as the Grunewald in 1893, it has welcomed a procession of Presidents of the United States, who like many others of the celebrated, inevitably came to a city famed for its regal entertainment. It was President Theodore Roosevelt, who visited the hotel, fresh from a Louisiana bear-hunt, who gave it its new name in 1925, when the re-building of the hotel was completed.

The first hotel in the United States to be completely air-conditioned, when this was completed in 1943, The Roosevelt has been rebuilt, re-conditioned, enlarged, improved so that it has continually held its high standard of being ready to serve well any guest, any entertainment, any convention, no matter how small or how large. Its fifteen meeting rooms accommodate from fifteen persons to a seating capacity of 2,250 in the elegant International Room.

In 1925, shortly after the Grunewald became The Roosevelt and changed ownership, the old three-story Baronne street section was torn down and a new and modern structure arose, with 285 rooms. This, with the 385 rooms in the 14-floor, University Street section gave the hotel a total of 670 rooms and baths.

In 1954 still another enlargement and beautification came with the erection of the Shell Building adjoining the hotel at University Place and Common Street, giving the new Common Street Section of the hotel 180 rooms and baths. During that year, 1954, the International Room was built, a large new coffee shop opened on University Place, the Plantation Room opening on the lobby was re-decorated, as were other dining rooms.

The Blue Room, smart center in New Orleans for dining and dancing and watching floor shows, has undergone frequent redecorations since it opened in 1937, replacing the Venetian Room for dining.

While maintaining a tradition of fine service for over half a century, The Roosevelt is continuously improving its facilities and its services.

General President

New Orleans . . .

WELCOMES OUR CONVENTION DELEGATES

NO other city in the United States is like New Orleans. It is a city of striking contrasts, of unique attractions and of rare charm. It is old and it is new; it is ancient and it is modern. It is a city of business and of pleasure.

New Orleans is perhaps the only city in this country which gives the visitor the feeling that he is both in the United States and out of it. It is truly an American city, but more than any other American city, it offers a distinct foreign atmosphere. The first impression of the visitor is that in New Orleans he has discovered something unique.

The charm of New Orleans is varied and there is no single thing which is wholly characteristic of her, just as there is no other city exactly like her. Visitors discover her personality only when they gather together the old city and the new, link the sentinels of the past with the monuments to the future and combine her fine old traditions with her vigorous modern ideas. New Orleans is, at one and the same time, the oldest city of the Mississippi Valley, the business city of the South, the second port of the nation in the value of foreign commerce, and in short, the city that one will never forget.

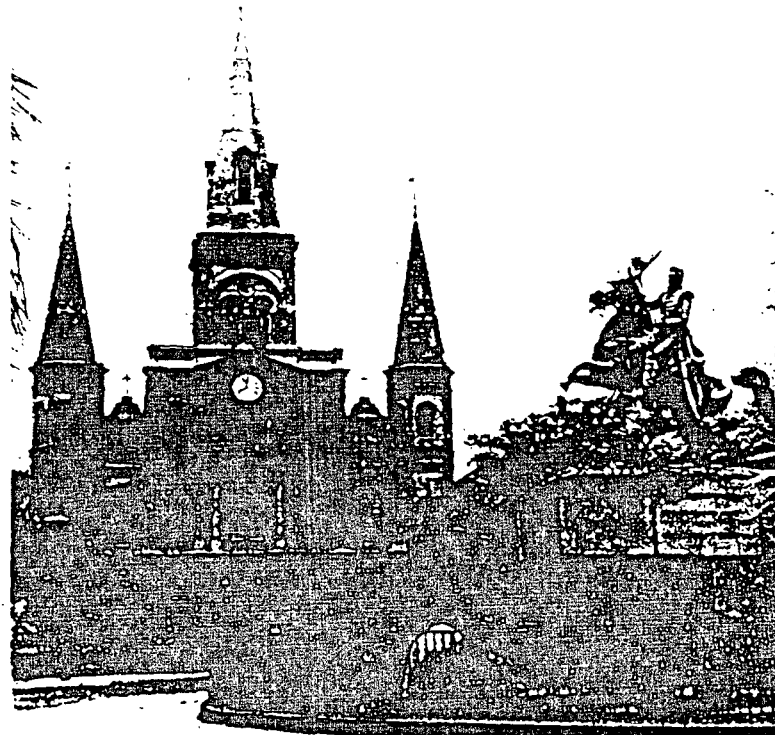
Sprawled in a huge bend of the Mississippi River a little more than 100 miles from its mouth at the Gulf of Mexico, New Orleans is a city firmly embedded in tradition, but it is by no means a slave to it. From a small French settlement in 1718, New Orleans has developed into a modern city of 600,000 people. Her first citizens were not necessarily frontiersmen but many were aristocrats of old France and old Spain. New Orleans, therefore, was born

of a well advanced civilization transplanted into the new world but unlike most other American cities, a peculiar reverence for the past has prompted her to preserve many of the landmarks of her early history. And pride in her long and varied career has kept alive traditions of the years gone by.

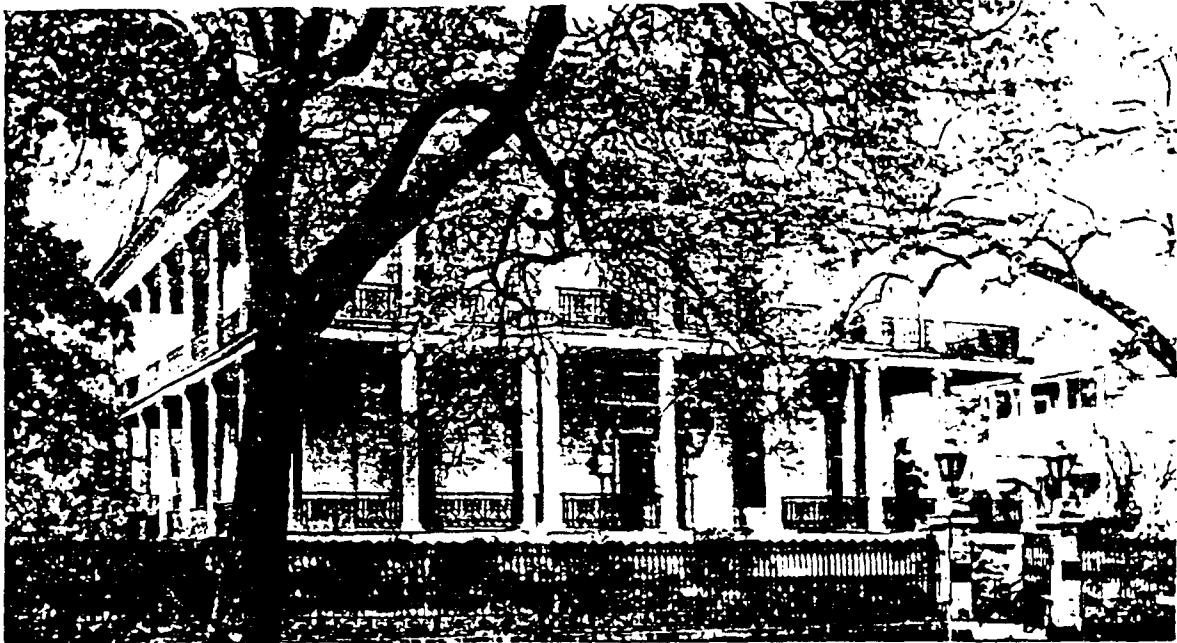
During the French and Spanish dominations, which started in 1718 and ended in 1803, French and Spanish influences combined to develop the Creole architecture which

is so characteristic of the Vieux Carre. In that old section of the city, one can capture all the old world atmosphere of early New Orleans very much as it was more than a century ago. The straight, narrow streets lined with structures of a strange architecture, the fancy ironwork adorning the balconies, the mysterious looking alleys and passageways, the lovely patios and many other features contribute to a strange, exotic setting.

Then, in 1803 the Americans

came and, ostracized by the Creoles, developed their own city above and below the Vieux Carré. Thus, in New Orleans can be found two cities with distinct personalities—one Latin and the other American, one old and one modern.

The Latin city is to be found in the Vieux Carré which, literally translated means "Old Square" but which is today more popularly known as the French Quarter. The heart of this old section of the city is Jackson Square which the French called the Place d'Armes. There the early settlers built the old parish church and there the St. Louis Cathedral, erected in 1794, stands to this day. The neighbors of the Cathedral are the Cabildo, named after the Spanish governing body, and the Presbytere or priest house. Flanking the square are two long red buildings known as the Pontalba Apartments which are believed to be the first structures of this kind to be erected in the United States. They were built by the Baroness Pontalba, daughter of a wealthy Spanish grandee, whose generosity made possible the Cathedral and other landmarks of today.

Although it is the focal point of the French Quarter, Jackson Square is by no means the only interesting part of it. With the exception of certain sections along the fringes

which have been commercialized, the entire quarter is noted for its old homes and buildings of quaint architecture and is famous for its old-world atmosphere and romantic tradition.

The French and Spanish inhabitants of early New Orleans were proud of their Latin heritage and resentful of any attempt to impose

a new system upon them or their city. Thus, when Louisiana became part of the United States in 1803 and there came a great influx of Americans with different customs and a different language, conflicts were bound to arise. The Americans, in turn, formed a colony of their own and what was virtually a different city developed on the opposite side of Canal Street which still divides the old city and the new.

Remaining from this period is that famous section of New Orleans known as the Garden District with almost as sharply defined boundaries as the Vieux Carré and with architecture in its way just as distinctive. Whereas in the Vieux Carré, the houses are closely massed and built flush with the sidewalks, the homes in the Garden District are more elaborate ante-Bellum structures set in the middle of landscaped grounds.

But it is not only with these relics of a glorious past that one catches the true fascination of New Orleans. To the visitor, the modern city, with its wide streets and avenues, its spacious residences, its beautiful parks, its miles of docks, its great industrial plants, its fine shops and excellent restaurants, is a source of interest that, in a way, matches the charm of the old city, especially as the sharp contrast of the two seems

to heighten the attractiveness of each.

Nothing could be more impressive than a drive along the miles of docks on the Mississippi River. And from this scene of physical activity it is just a few blocks to the executive offices of business and industry. Modern New Orleans in recent years has seen giant airplanes come and go at three airports. It has seen thousands of acres of land reclaimed from Lake Pontchartrain into one of the finest residential sections of the South. It has seen the majestic Huey P. Long Bridge rise over the Mississippi River where many engineers said no bridge could be built. And it has seen this mighty river, at flood stage, subside at the opening of the Bonnet Carré Spillway, an achievement of U. S. Army engineers. International House, International Trade Mart, the Foreign Trade Zone and the new union railroad station are but a few of the other monuments to progress which modern New Orleans has erected.

The port is the main economic lifeline of the city. It is the country's second greatest port in the valuation of exports and imports. It is the ocean gateway for the Mid-Continent area of the United States which includes 55 per cent of the total area of the country and 41 per cent of its population.

To handle the world trade of this great Mid-Continent empire, New Orleans has supplied port facilities that are second to none in the United States. These facilities have a valuation of more than \$300,000,000 and they include more than 11 miles of wharves equipped with many types of mechanical devices. The records of the U. S. Army indicate that the facilities of the Port of New Orleans accounted for lower cost and more efficient operation during World War II than at any other port of embarkation in the United States.

Feeding the port and contributing to the importance of the city as a distribution center, is the most harmonious combination of transportation facilities to be found in the United States. Eight major railroads, which constitute 20 per cent of the Class I railroad mileage of the U. S., serve New Orleans.

Barge lines operate from New Orleans on regular schedules to points on the Mississippi, Ohio, Illinois, Missouri, Red, Warrior and other rivers and through the Intra-coastal Canal east and west of the city. Coastwise steamship service is available to the Atlantic, Pacific and Gulf Ports. Foreign steamship service from New Orleans is more extensive and regular than from any other port in the United States except New York.

In the field of aviation transportation, New Orleans ranks as one of the major terminals of the world. The New Orleans air pattern includes not only routes to the important cities of the United States but also services across the Gulf of Mexico and the city is recognized as the air hub of the Americas.

Another important economic factor enjoyed by New Orleans is the availability of raw materials. Louisiana is a natural storehouse of such materials, including oil, sulphur, natural gas, limestone and salt. The state has extensive forests, produces most of the fur-bearing animals trapped in the United States, has extensive seafood industries. In addition, the position of New Orleans as a major port enables it to draw upon the world for a constant source of raw materials not produced in this country.

Today, New Orleans is making its greatest growth in the industrial field. In pre-war 1939, manufacturing establishments in New Orleans employed about 25,000 workers. Industrial employment in the area is now more than 52,000 and the annual industrial payroll has increased by more than 600 per cent.

One of the significant features of the industrial growth of the New Orleans area is that most of it was made during the period following

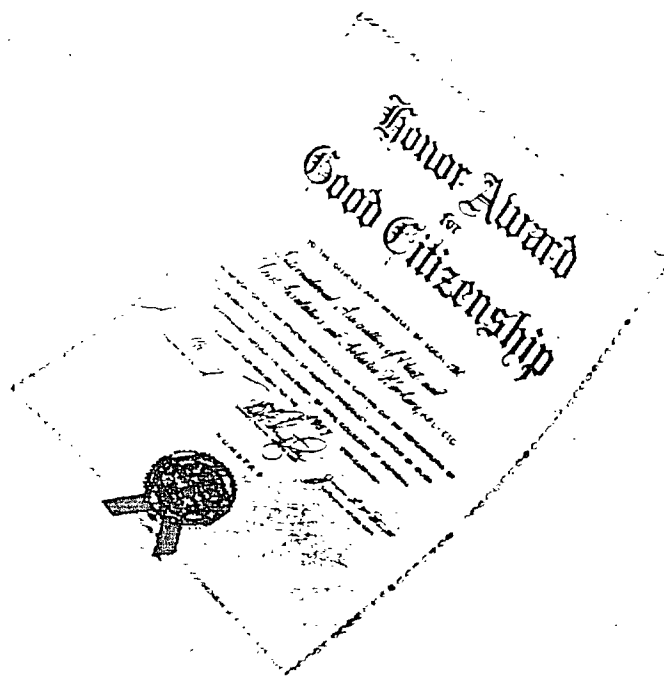
The business district of the Crescent City, looking down Canal Street from the Mississippi River docks. New Orleans is a leading port city. It calls itself "The Gateway to Latin America."

World War II, giving evidence of the fact that the city not only retained the gains which came during and as a result of the war but also added substantially to them. Investments in new and expanded industrial facilities during the postwar period have amounted to more than \$700,000,000. New Orleans has become the center of the country's largest aluminum production operation and the cordage capital of the country. Many of its new acquisitions have been in the chemical field, suggesting the growth of the area into a vast chemical empire.

The remarkable expansion made by the petroleum industry in the New Orleans area has been one of the most important elements in its industrial progress. That industry, in recent years, has learned how to operate in what once was considered the inaccessible marsh areas of the Southern part of the state. As a result, there are now more than 90

active oil fields, embracing more than 3,000 oil and gas wells within a 100-mile radius of the city. And the construction of the oil companies of many multi-story office buildings in the city would seem to indicate the importance that that industry attaches to the continued growth of New Orleans as an oil center.

New Orleans is also noted for its natural beauty. Because of the harmonious combination of ample rainfall and sunshine, aided by a balmy climate that is minus the extremes in both summer and winter, plant life grows luxuriantly and the city presents a park-like appearance. Two of the public parks, Audubon and City, are devoted to retaining the natural beauty of the early Louisiana scene. In them and throughout other parts of the city can be found many varieties of palms and massive old live oaks draped with long beards of Spanish moss. The city has a floral trail along many miles of its streets, avenues and boulevards which is multi-colored with azaleas and other flowers at a time of the year when

most other parts of the country are covered with ice and snow.

With a climate that permits outdoor activity 12 months of the year, the opportunities for recreation in New Orleans are unbounded. Lake Pontchartrain offers bathing and boating. Fresh and salt water fishing is possible through all months of the year within and near the city and migratory waterfowl use the Louisiana coastal areas as their winter haven. The Mardi Gras, the Sugar Bowl Classic which climaxes the Mid-Winter Carnival of Sports, and the Spring Fiesta are annual peak tourist attractions. The night life of the city is varied, unique.

There is no need for a dull moment in New Orleans as one will readily find when he goes there. Within the 363.5 square miles that is New Orleans, from the beautiful lakefront to the mighty, curving river are innumerable points of interest, modern and ancient that explain emphatically why the city is so widely known as the South's greatest city and America's most interesting city.

TO ALL AFFILIATED LOCAL UNION BUSINESS AGENTS OF
THE INTERNATIONAL ASSOCIATION OF HEAT AND FROST
INSULATORS AND ASBESTOS WORKERS

DEAR SIRS AND BROTHERS:

We are pleased to inform you that the General Officers of the International Association of Heat and Frost Insulators and Asbestos Workers and the Sheet Metal Workers' International Association, after many conferences in an effort to settle questions of a jurisdictional nature between our two International Unions, have arrived at two (2) agreements which are covered in this agreement booklet. During the past several months (upon request of the National Joint Board for Settlement of Jurisdictional Disputes) the General Officers of the Heat and Frost Insulators and Asbestos Workers have met with the General Officers of the Sheet Metal Workers with the hope of resolving our differences pertaining to "Duct Insulation" and "Metal Lagging over Insulation." Mr. John Dunlop, Chairman of the National Joint Board, presided and monitored these meetings.

At the last meeting held in Washington, D. C., on May 15, 1957, which was attended by the General Presidents and General Secretary-Treasurers of both International Unions along with the Committees of both International Unions, the attached Agreements between our two International Unions were duly signed by the respective General Officers. Representing Heat and Frost Insulators and Asbestos Workers were C. W. Slicks, General President, Hugh E. Mulligan, International Vice President and John W. Hoff, General Secretary-Treasurer. Representing Sheet Metal Workers were Robert Byron, General President, A. H. Cronin, General Vice President and Edward Carlough, General Secretary-Treasurer. Mr. John Dunlop represented the National Joint Board of Settlement of Jurisdictional Disputes.

It was also agreed at the time of signing these agreements that no disputes which might occur between our respective affiliated Local Unions will be sent to the National Joint Board for Settlement of Jurisdictional

Disputes. Building and Construction Industry and the officers of both International Unions agreed that all disputes which might arise between our respective organizations shall be handled on the local level in keeping with the terms of these Agreements and all interpretations that may be required covering any part of these agreements will be made by the General Officers of our respective organizations, unless otherwise determined by the International Presidents or their duly authorized representatives of either organization.

Further, any disputes covering work not set out in these Agreements will be handled in the following manner. The first attempt to be made by the Local Union representatives in the area, and upon failure to resolve the disputed work question the matter will then be referred to an International Representative of each organization; and upon failure of their settling the work in question the entire matter will be referred to the General Presidents signatory to these Agreements or their duly authorized representatives.

Intent and Explanation

These agreements cover jurisdiction of "Duct Insulation" and "Metal Lagging over Insulation" and although signed under date of May 15, 1957, and by mutual consent of the two organizations are to become effective June 15, 1957.

Any work started on or after June 15, 1957, is to be covered by these agreements and any work that would be covered by either of these two agreements and was started prior to June 15, 1957, will continue until its completion by the trade doing the work prior to that date.

Thermal insulation as used in the agreement covering "Duct Insulation" was understood and agreed between the parties signing this agreement to include all insulation used for the purpose of control of temperatures, either hot or cold.

With reference to paragraph 3 of the agreement covering "Duct Insulation," it was the intent of the respective committees that so far as the work set forth in this paragraph being done at the job site was so worded for the specific purpose of assuring that no Thermal insulation whatever was to be applied at any location other than the job site and then by the members of the International Association of Heat and Frost Insulators and Asbestos Workers.

We desire to bring to your attention that a committee of three from both the Insulation Contractors National Association and the Sheet Metal Workers Contractors National Association met jointly and later together with the committee representing our respective International Associations and have approved and endorsed these agreements.

In conclusion, we are confident that the working re-

relationship between our memberships will be greatly benefited, and of equal, if not greater importance, our bargaining position with employers in the industry will be greatly strengthened.

We pledge ourselves to carry out the full intent and purpose of these agreements and to call upon our membership, representatives and officers to approach this task as a unified force that will ultimately succeed in organizing every eligible member in our respective organizations.

These two agreements dated May 15, 1957, displace in their entirety the two agreements of July 12, 1956, previously signed by General President Byron of the Sheet Metal Workers' International Association and your General President and any and all copies of the July 12, 1956, agreements should be destroyed to avoid any confusion in the future.

AGREEMENT between the SHEET METAL WORKERS' INTERNATIONAL ASSOCIATION

and the INTERNATIONAL ASSOCIATION OF HEAT AND FROST INSULATORS AND ASBESTOS WORKERS

Duct Insulation

Agreement entered into this 15th day of May 1957, by and between the Sheet Metal Workers' International Association and the International Association of Heat and Frost Insulators and Asbestos Workers covering the application of insulating and accoustical materials on inside and outside of sheet metal ducts and fittings in connection with ventilation and air conditioning systems for the purpose of interpreting and clarifying the agreement of record of April 13, 1939, between the two organizations.

It is expressly understood and agreed that this agreement shall not relate to nor have any bearing on jurisdictional disputes that may exist or in the future occur between either of the parties hereto with any other international union or subordinate body thereof.

1. All insulating materials applied on outside of sheet metal ducts and fittings is recognized as coming within the jurisdiction of the International Association of Heat and Frost Insulators and Asbestos Workers.

2. All materials required for the prime function of accoustical treatment applied inside the sheet metal ducts and fittings in shop or on job site is recognized as coming within the jurisdiction of the Sheet Metal Workers' International Association.

3. All materials required for the prime function of thermal insulation applied to sheet metal ducts and fittings on job site is recognized as coming within the

jurisdiction of the International Association of Heat and Frost Insulators and Asbestos Workers.

4. All materials applied inside the fan housings, all casings, fresh air intakes, plenum chambers, etc., is recognized as coming within the jurisdiction of the International Association of Heat and Frost Insulators and Asbestos Workers.

5. The exception to the above, par. 4, is in the instance where a casing or plenum chamber consists of a sandwich of two layers of sheet metal material with insulation material between same and entirely prefabricated in shop, this work shall be within the jurisdiction of the Sheet Metal Workers' International Association. Further, on fresh air intakes, where a sound trap is called for—installed in the field—this installation shall be recognized as the work of the Sheet Metal Workers' International Association.

Committees of the two organizations shall review annually, or at such other times as are mutually agreeable, the operation of this agreement and shall make such changes as are mutually agreeable in this agreement.

Any dispute or controversy arising out of the application or interpretation of this agreement shall be referred to and settled immediately by the General Presidents of the two International Unions involved or their designated representatives, in accordance with the purpose and intent of this agreement.

AGREEMENT between the SHEET METAL WORKERS' INTERNATIONAL ASSOCIATION

and the INTERNATIONAL ASSOCIATION OF HEAT AND FROST INSULATORS AND ASBESTOS WORKERS

Metal Lagging Over Insulation

AGREEMENT entered into this 15th day of May 1957, by and between the Sheet Metal Workers' International Association and the International Association of Heat and Frost Insulators and Asbestos Workers covering the installation of aluminum as a finish over insulating materials and insulation and metal lagging jointly prefabricated prior to delivery at job site.

It is expressly understood and agreed that this agreement shall not relate to nor have any bearing on jurisdictional disputes that may exist or in the future occur

between either of the parties hereto with any other international union or subordinate body thereof.

1. All aluminum being applied over and as a finish for insulation shall be recognized as coming within the jurisdiction of the International Association of Heat and Frost Insulators and Asbestos Workers, when said aluminum is not heavier than .016 gauge.

2. All aluminum heavier than .016 gauge shall be recognized as within the jurisdiction of the Sheet Metal Workers' International Association.

3. The Brown and Sharp U. S. Standard Gauge No. 24 for sheet and plate iron and steel shall be the gauge used for determining thickness as set forth above.

4. Where insulation and metal lagging is prefabricated prior to delivery to job site the installation of same shall be applied by a composite crew of Asbestos Workers and Sheet Metal Workers on a 50-50 basis.

Committees of the two organizations shall review annually, or at such other times as are mutually agreeable, the operation of this Agreement and shall make such changes as are mutually agreeable in this Agreement.

Any dispute or controversy arising out of the application or interpretation of this Agreement shall be referred to and settled immediately by the General Presidents of the two International Unions involved or their designated representatives, in accordance with the purpose and intent of this Agreement.

SUBJECT: Attachment of Lugs, Clips, Wires or other
Fastening Devices for Insulation to Vessels
and Equipment Installed by Boilermakers

1. Where the Nelson Stud Gun or similar equipment is used on the construction site to attach lugs, clips, wires or other fastening devices to boilers, tanks, ducts, branching precipitators, stacks, or other boilermaker installations for the purpose of fastening insulation to be applied by Asbestos Workers, the attachment of such devices will be performed by Asbestos Workers, except

that attachment directly to boiler tubes, by any method of welding, will be performed by Boilermakers.

2. Where lugs, clips, wires, or other fastening devices are attached to boilers, tanks, ducts, branching, precipitators, stacks, or other boilermaker installations for the purpose of fastening insulation to be applied by the Asbestos Workers, the attachment of such devices by what is commonly termed hand welding methods, will be performed by Boilermakers.

Italian Labor

Leader Says Red Unions Slipping

A LEADING Italian labor leader visiting Milwaukee recently said that the Communist grip on labor unions in Italy has been drastically reduced by the vigorous action of free trade unions both in Italy and abroad.

Francesco Ferrero, president of the Metal Workers Union of Italy, said the aid and example of the labor movement in the United States

and Canada was a source of inspiration to the Italians. He also warmly commended the International Metal Workers Federation for their "unwavering and valuable aid in exposing the false doctrine of the Communist movement."

Ferrero explained that his visit has one main purpose. He wants to learn about America, its traditions, its customs, its freedoms and particularly its trade unions which have been "like a Northern Star to us in our battle to re-establish democratic trade unions in Italy."

As recently as five years ago, Ferrero said, "the Communists controlled 80 per cent of the unions in my home province of Turin. Strange as it may seem, some of their financial strength came from industrialists who contributed to Red coffers for their own reasons."

"My own union was born with the help of the International Metal Workers Federation," Ferrero continued, "to give the workers a democratic alternative to communism. Using your American unions as our model, we concentrated on bread and butter issues—higher wages, more jobs."

"The Commies, meanwhile, were busy with political strikes and demonstrations against the Marshall Plan, NATO and the European Coal and Steel Community."

"It did not take the rank and file workers long to discover where their best interests lay."

"They saw the good results of American aid and of European co-operation. No help came from the Soviets."

"Today," Ferrero declared proudly, "Communist union strength in Turin is down to 20 per cent. Since the decline of the Reds, wage rates in our metal working plants have doubled."

MINUTES OF CONFERENCE MEETINGS

New York-New England States

Albany, N. Y.
June 8, 1957

The semi-annual meeting of the New York-New England States Conference of Asbestos Workers was held at the Ten-Eyck Hotel in Albany, N. Y., on June 8.

General President C. W. Sickles, General Secretary-Treasurer John W. Hoff and Vice President George Rider were in attendance.

The meeting was called to order at 10 a. m. by President John R. McCormick and the following delegates responded to roll call: Local No. 12, New York City, N. Y., George Rider and Patrick O'Connor; Local No. 30, Syracuse, N. Y., John R. McCormick and Matthew Costello; Local No. 40, Albany, N. Y., Robert McCaffrey and Joseph Case; Local No. 4, Buffalo, N. Y., Arthur J. Forton; Local No. 26, Rochester, N. Y., Herbert A. Lord; Local No. 91, White Plains, N. Y., Harry J. Herbst and Clarence Demers; Local No. 43, Springfield, Mass., E. H. Blair and Donald Gray; Local No. 31, Providence, R. I., Prescott Jentzel; Local No. 33, Connecticut, Joseph Murphy and James Piggott; Local No. 6, Boston, Mass., George Anderson and Herbert G. Anderson.

Also in attendance as visitors were Edward Kellner, Local No. 12; Edward Oliver, Gerald LaMont, Fred Gudz, and William Picord, Local No. 40; Leslie Johnson and William Kelly, Local No. 33; Patrick I. Fagan and S. P. Merola, Local No. 104; and Joseph Chapus, Local No. 4.

Minutes of the previous meeting were accepted as printed in the October, 1956, JOURNAL.

Reading of the financial status of this Conference was accepted as read.

Delegate Arthur J. Forton, Local No. 4, reports a membership of 124 comprised of 91 Mechanics and 33 Improvers with an additional six Travelers currently employed. Agreement to be opened June 1, 1958. Pension payments will begin June 1, 1958. Retirement benefits to be \$90 monthly with five members eligible. Christmas to be a paid holiday. Board rate will be increased to \$8.50 per day based on

a five-day week. Wage rates to be increased 20 cents per hour for Mechanics and 10 cents per hour for Improvers. A large power house is under construction. Men are working seven 12-hour days, the only expense job is the Niagara operation.

Delegate Herbert G. Anderson, Local No. 6 reports work in the area favorable with full membership employed. Agreement expires August 31, 1957. Employers have been invited to commence negotiations but no meetings have been held as yet. Expansion of paper mill facilities in the State of Maine, plus three generating plants, with numerous school houses, constitute the bulk of our current work. Rehabilitation of defaced areas in the city of Boston is looked forward to for future work, such as construction of new office buildings, hotels and high cost housing projects to be financed by insurance companies and private capital. Soundings have been started for construction of the \$28 million Prudential Insurance Company building. Land has already been cleared for the construction of an industrial area in the south end. Land taking will begin soon in the west end for the purpose of constructing high cost apartment dwellings. Membership report, 225 Mechanics, 45 Improvers and several Travelers also employed.

Delegates George Rider and Patrick O'Connor of Local No. 12 report work at the present as good with no overtime or expense jobs. Agreement expires June 30, 1957, with no report from employers at this writing. Present membership, 474 Mechanics and 111 Improvers.

Delegate Herbert A. Lord, Local No. 26, reports work at present very good. Now in process of completing power house job. Future work consisting of school house and industrial projects that should keep the membership employed for at least six months. Report on membership, 39 Mechanics, 9 Improvers.

Delegates John McCormick and Matthew Costello of Local No. 30 report present conditions good with full employment. Jobs are of the ordinary run of the mill of no particular size or importance, but a large job in progress in northern

New York is not yet ready for insulation. Present rate \$3.35 per hour. Membership report, 35 Mechanics and 15 Improvers.

Delegate Prescott Jentzel of Local No. 31 reports work fair at present with future prospects good. Membership is fully employed due to assistance of neighboring locals. The year 1958 is looked forward to as being the best ever with plans for a new oil refinery in the area. Present membership, 85 Mechanics, 26 Improvers. Eighty members working in home territory.

Delegates Joseph Murphy and James Piggott of Local No. 33 report work as good. One power house job is now in progress, two are in the offing. Several large jobs are finishing up, but feel confident of full employment for the membership for some time to come. Negotiations on their new agreement are currently in progress. Membership report, 164 members with five on Traveling Cards and five Travelers in the territory.

Delegate Robert I. McCaffrey, Local No. 40 reports work load as fair. Results of negotiations at present, although agreement has not yet been signed, are as follows: Three-year contract; 15-cent increase first year, 15 cents second year and 15 cents third year with 10-cent Welfare Fund.

Delegate Ernest Blair of Local No. 43 reports conditions in that territory as excellent. Total membership of 70 with 58 Mechanics and 12 Improvers. Have 20 Travelers working and can use more Travelers. Does not have too many subsistence jobs, but there is plenty of work and the future looks very good. There is one very sore spot in the Worcester area that he hopes can be settled once and for all at this Conference. More of this later.

Delegate Harry J. Herbst of Local No. 91 reports total membership of 62 with 42 Mechanics and 16 Improvers, three members in Armed Forces and one member on Traveler. Agreement expires approximately one year from this date. Report on work, very good. Future prospects also very good with all members working.

It was moved by Delegate Herbert Anderson and seconded by Delegate Joseph Murphy that this Con-

ference go on record as endorsing Vice President George Rider as also all of the present International Officers at our coming International Convention to be held in New Orleans in September of this year. Motion carried.

Request to our General Office by the membership of Local No. 104, New York Naval Shipyard for affiliation in this Conference was made and a committee of two were invited to attend this Conference for the purpose of stating their case. Brothers Patrick J. Fagan and S. P. Merola of Local No. 104 attended. After discussing the merits of their case President C. W. Sickles rose to state that the problems involved in a Shipyard local and those of a building trades local are so far apart that it would not be advisable or practical to accept the affiliation of a Shipyard Local with this Conference. The Conference did on motion duly seconded vote unanimously to refuse affiliation to Navy Yard Local Unions. Delegate Anderson stated his experiences with the membership of Local No. 98 Boston Naval Shipyard and will always be glad to honor their Traveling Cards whenever work in the area warrants it.

After hearing reports of the delegates and their statements of heavy work loads, present and future, the problem of manpower to properly service our trade was discussed. President Sickles stated that the importance of bringing our Improver ratio up to the legal status, as provided for in our International Constitution, is imperative at this time and instructed those locals that have not complied to do so.

The unpleasant situation that persists in the Worcester area was again brought to the attention of the Conference. President Sickles described it as a "cesspool area" and advised that he had already made tentative plans to visit Worcester and at that time meet with all interested in our craft problem in that area including the New England Local Union Business Agents which visit he expects to make in the early part of July and at that time every possible effort will be made to bring about a satisfactory adjustment of the situation which has for some time past existed in and around the Worcester, Mass., area.

The question of premium wages was discussed with its relative pros and cons. President Sickles enlightened the delegates as to its

fallacies as practiced in other areas and stated that one local union had set up a variety of foreman rates based on the number of men employed on the job. Complications arose from the shifting of men to and from the job, and increasing or decreasing its complement, thus causing confusion that was difficult to cope with. President Sickles stated that he does not condone this practice as it sets up a multiple classification of journeymen as opposed to our International Constitution.

The problem of hazardous materials was again discussed with the importance of using preventative measures to eliminate inhalation, irritation, and possible infection stressed. It is suggested that, when working under dusty conditions, respirators should be used at all times and gloves whenever conditions warrant.

In reply to inquiry raised by delegates, President Sickles made a short reply in connection with the correspondence course which has been going around the country during the last two months which correspondence initiated out of Local No. 5, and assured the Conference delegates that these communications, paragraph by paragraph, will be analyzed and answered at the proper time and place, namely, the next scheduled International Convention which will be held in New Orleans the first week in September.

The Conference goes on record as instructing those local delegates attending the International Convention at New Orleans to meet during Convention Week to discuss its problems.

Many of the delegates present inquired about Brother Abram Goldberg of Local No. 6 and they all wish him a speedy recovery from his present illness.

Successful culmination of the agreement between the Asbestos Workers International and the Sheet Metal Workers International Association was elaborated upon by President Sickles. The many setbacks and heartaches attendant upon the many meetings required for the formulation and conclusion of such an agreement are not generally understood by our membership. We are deeply grateful to our General President C. W. Sickles, General Secretary-Treasurer John W. Hoff and Vice President Hugh E. Mulligan for bringing this problem to a successful conclusion.

There being no further business

before the Conference, adjournment was declared at 1:45 p. m.

Editor's Note — Following adjournment of the Conference meeting a meeting of the agreement committee of Local No. 40, and the employers, was held with General President Sickles and General Secretary-Treasurer Hoff in attendance, and the newly negotiated Joint Trade Agreement amended to overcome objections raised by President Sickles during the Conference meeting which, among other things, provided for a reopening clause at the start of the third year insofar as wage rates were concerned and they could then be adjusted to meet any unusual economic changes in the wages of the building trades of Albany and vicinity if such further adjustments were found warranted.

ICFTU Lauds UN Report On Hungary

THE International Confederation of Free Trade Unions has welcomed the report of the United Nations Special Committee on Hungary as an expression of the public opinion that must be mobilized on a worldwide scale if the Hungarian people are to be delivered from their Soviet oppressors.

At the same time, it recognized the responsibility of the ICFTU itself.

"The free trade unions of the world will not let pass a single opportunity to protest the suppression of freedom in Hungary and to express their sympathy with the Hungarian people," the international labor body said in a statement.

"The report incidentally brings fresh evidence of the fact," the ICFTU said, "that the Communist-controlled World Federation of Trade Unions is a willing tool of the Kremlin. The WFTU has given its unflinching support to (Premier) Kadar and the Soviet government in the policy of crushing the Hungarian revolution."

THE UNLADYLIKE BEHAVIOR OF MARIA MITCHELL

In a quiet house in Lynn, Massachusetts, in 1889, an old woman lay waiting for death. "Well," she said in amused wonder, "if this is dying, there is nothing very unpleasant about it." And the book closed for one of the most remarkable of the many remarkable women America has produced.

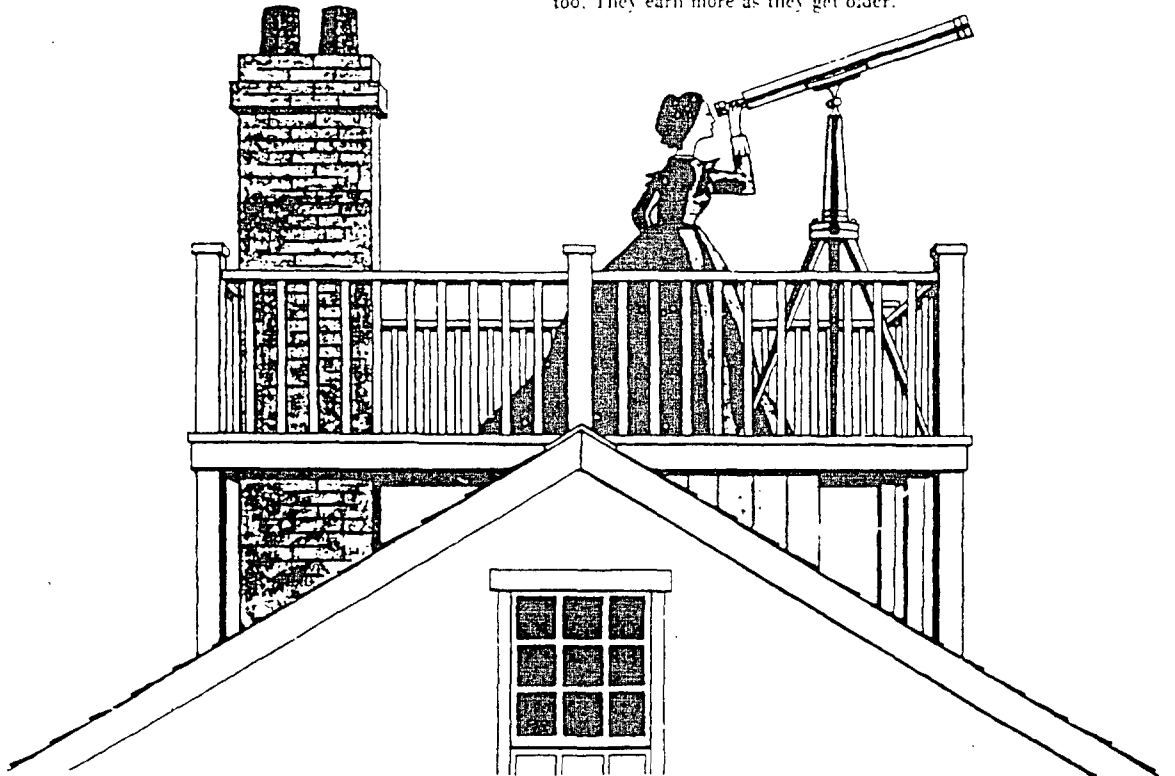
