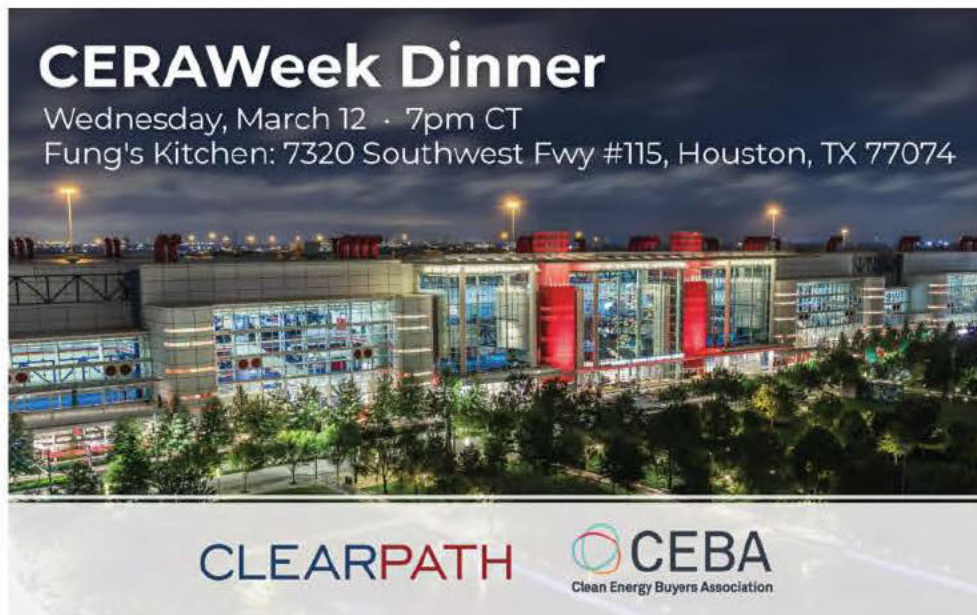
Hi Alex,
