Dear Ms. Miller:

I am pleased to advise that we finally received the Amended Order Approving Compromise and Release for the above-referenced matter. We previously received the original Order Approving Compromise and Release for this matter but unfortunately Judge Kirner mistakenly included a Rodgers rather than a Thomas in that Order. I sent you a copy of the original Order with my letter to you dated April 21, 1993 and I assume that the Order has been placed in line for payment.

I wrote to Judge Kirner on multiple occasions requesting that he issue an Amended Order that includes a Thomas finding pursuant to the agreement in the Compromise and Release. We finally received the Amended Order dated August 9, 1993 by Judge Kirner which rescinds his prior Order. Enclosed please find a copy of the August 9, 1993 Order.
