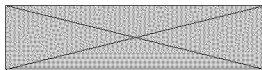

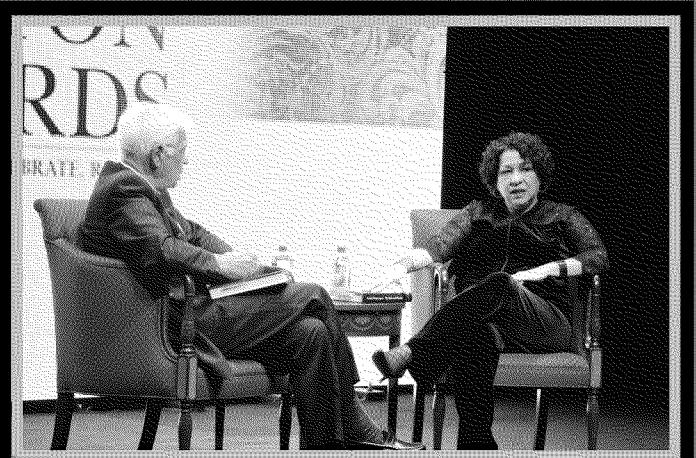
## Specifics of the 2017 Burton Awards Program

## The Burton Awards: An Established Tradition in Law

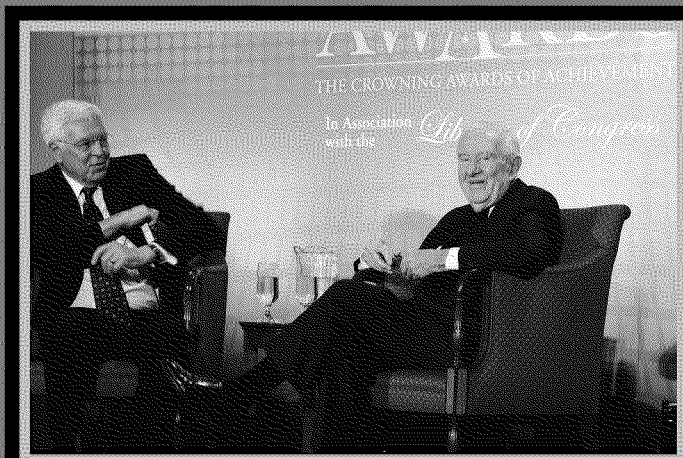
