General Policy**APPROVAL OF HIGHWAY VIOLATES NEPA, CEQ ADVISES TRANSPORTATION DEPARTMENT**

The Department of Transportation's conditional approval of the Connecticut portion of highway I-84 between Hartford, Conn., and Providence, R.I., was not legal under the National Environmental Policy Act. Council on Environmental Quality Chairman Gus Speth told DOT Secretary Neil Goldschmidt in an April 30 letter.

Further, Speth said, I-84 as it is expected to be constructed will be environmentally harmful to the Scituate Reservoir and its watershed, which are the sole drinking water sources for the Providence metropolitan area, and the project therefore is "environmentally unacceptable."

CEQ's position on the I-84 project was rendered as the result of questions raised by the Environmental Protection Agency, which commented on the project in accordance with its statutory duties under NEPA and under Section 309 of the Clean Air Act. EPA sought CEQ's views under the referral provisions of the council's NEPA regulations.

Speth told Goldschmidt, in the April 30 letter and an accompanying legal memorandum, that the NEPA problem with respect to I-84 stems from the segmentation of the contemplated Hartford to Providence route.

The conditional approval and commitment of design funds for the Connecticut portion of the route prior to completion of the environmental analysis of the remaining Rhode Island segment prejudices the selection of route and other alternatives for the latter and thereby violates NEPA, Speth said.

The approval of the route location for the Connecticut portion of the highway also has created a bias in favor of a particular route alternative in Rhode Island, which would traverse the Scituate Reservoir, Speth said.

Construction of the highway across the Scituate Reservoir and its watershed would cause "serious and substantial threats to the water supply" because of construction, operations, accidents, and secondary developments, Speth said. If a spill of toxic materials occurred, Speth said, the Scituate water supply would have to be limited or closed.

The I-84 route across the Scituate therefore is "environmentally unacceptable," Speth said, and the selection of that alternative would violate Section 101(b)(2) and (3) of NEPA.

Air Pollution**EDF PROPOSES ECONOMIC INCENTIVES TO REDUCE VINYL CHLORIDE EMISSIONS**

Saying that there have been an increasing number of emergency vinyl chloride emissions over the past two years, the Environmental Defense Fund (EDF) proposed economic incentives to reduce discharges.

In a letter to Environmental Protection Agency Administrator Douglas M. Costle April 18, EDF staff attorney Larry Corcoran outlined a plan which would levy fines in proportion to the magnitude and frequency of discharges. Acknowledging that some emergency discharges are unavoidable, EDF suggested a sliding fine schedule with penalties set large enough to create a financial incentive for improvement within industry. However, these fines would not be a discharge tax; EDF said it wants EPA to emphasize that no discharges are environmentally acceptable.

With this proposal EDF requested stricter enforcement of regulations requiring prevention of vinyl chloride emergency releases. An EDF review of industry compliance submissions indicates that compliance with national emissions standards is poor in respect to preventive measures, Corcoran said. Many plants have experienced a substantial increase in the number of emergency discharges in 1978 and an even greater number in 1979, he continued, stating that a review of selected industry reports implied discharges are the result of chronic problems that industry fails to address.

The National Standards for Vinyl Chloride prohibit all relief discharges into the atmosphere except for an emergency release. EDF said its review indicates many plants have not been concerned with reducing discharges, which has led to an ever-increasing number that may be reduced only by economic incentives.

To date, EPA has made no reply to Corcoran's letter.
