I am pleased to invite you as a featured speaker in the Aspen Institute's Washington Ideas Roundtable Series—monthly lunchtime dialogues featuring key policymakers discussing the evolving role of the United States in world affairs. A sampling of past speakers in the series include, among others: then-Homeland Security Secretary Janet Napolitano, then-Under Secretary of Defense Michèle Fluornoy, Senators Dianne Feinstein and Richard Lugar, former national security advisors Brent Scowcroft and Zbigniew Brzezinski, former Secretary of State Madeleine Albright, and King Abdullah II of Jordan.

Additionally, we would also like to extend an invitation for you to speak at and attend the Aspen Energy Week, July 12-16 in Aspen, CO, presented by the Aspen Institute's Energy and Environment Program. Aspen Energy Week, part of a line of energy forums in Aspen for over the past 40 years, is a four-day forum focusing on the US power sector and electricity system. This group of experts and professionals in the energy sector discuss a variety of topics in Aspen's trademark forum format: a moderated roundtable that stresses dialogue between participants, rather than question and answer or merely listening to speakers on a stage.
