Section I – INTRODUCTION

PURPOSE OF THE INSPECTION

EPA Region 6 inspectors Kerri McCabe (lead) and Uma Lad arrived at the Williamson Pumping Service, Inc. / Lester-Patton 32 Tank Battery ("facility") located from State Highway 82 East, right on State Highway 29, and left on lease road at 33.325419, -93.580597 in Lewisville, Lafayette County, Arkansas; at 1615 on 01/12/2026 for an unannounced inspection. No facility representatives were present at the time of the inspection. The inspection was conducted by the authority of the Clean Water Act (CWA) to determine compliance with Environmental Protection Agency (EPA) regulations. There were no other federal, state, or local agency representatives present at the time of the inspection.

FACILITY DESCRIPTION

EPA conducted an inspection on the Williamson Pumping Service, Inc. / Lester-Patton #2 Tank Battery facility, which contained one (1) tank battery with four (4) tanks for oil storage. Note: Newton A-1 and Lester-Patton #2 production wells share the same tank battery with two (2) storage tanks for each production well.
